

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public & Behavioral Health & Human Services.

HB22-1256 be amended as follows:

- 1 Amend printed bill, page 31, strike lines 5 through 27.
- 2 Strike pages 32 and 33.
- 3 Page 34, strike lines 1 through 24 and substitute:
 - 4 **"27-65-108. Care coordination for persons certified or in need**
 - 5 **of ongoing treatment.** (1) THE BEHAVIORAL HEALTH ADMINISTRATION
 - 6 SHALL, DIRECTLY OR THROUGH CONTRACT, PROVIDE CARE COORDINATION
 - 7 SERVICES TO A PERSON CERTIFIED PURSUANT TO SECTION 27-65-109,
 - 8 27-65-110, OR 27-65-111, INCLUDING A PERSON WHOSE CERTIFICATION IS
 - 9 TERMINATED BUT WHOM THE BHA DETERMINES IS IN NEED OF ONGOING
 - 10 TREATMENT AND SERVICES.
 - 11 (2) THE BHA SHALL PROVIDE CARE COORDINATION SERVICES TO
 - 12 SUPPORT A PERSON WHO IS DISCHARGING FROM CARE, TRANSFERRING
 - 13 PROVIDERS, OR SECURING OTHER SUPPORTIVE SERVICES. A FACILITY
 - 14 DESIGNATED BY THE COMMISSIONER SHALL NOTIFY AND ENGAGE THE
 - 15 BHA PRIOR TO TERMINATING OR TRANSFERRING ANY CERTIFICATION."
- 16 Page 43, lines 16 and 17, strike "COMMITTED TO THE CUSTODY OF THE
- 17 BEHAVIORAL HEALTH ADMINISTRATION" and substitute "CERTIFIED".
- 18 Page 43, lines 19 and 20, strike "PROVIDER, IN COLLABORATION WITH THE
- 19 BHA," and substitute "PROVIDER".
- 20 Page 44, strike lines 8 through 10 and substitute:
 - 21 "(2) THE RESPONDENT, THE".
- 22 Page 68, strike line 24 and substitute "65."
- 23 Page 92, strike lines 9 through 14 and substitute:
 - 24 "(4) Upon certification of the respondent, the facility designated
 - 25 for short-term treatment has behavioral health administration has custody
 - 26 of the respondent."
- 27 Page 92, lines 20 and 21, strike "~~certifying and treating professional~~
- 28 ~~person~~ BEHAVIORAL HEALTH ADMINISTRATION" and substitute "certifying
- 29 and treating professional person".
