

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB22-1132 be amended as follows:

1 Amend printed bill, page 4, after line 8 insert:

2 "SECTION 2. In Colorado Revised Statutes, 24-33.5-1207.5,
3 **amend** (1); and **add** (3) as follows:

4 **24-33.5-1207.5. Fire service education and training fund -**
5 **created.** (1) ALL MONEY TRANSFERRED IN ACCORDANCE WITH
6 SUBSECTION (3)(a) OF THIS SECTION, all ~~moneys~~ MONEY received by the
7 director pursuant to the administration of the fire service education and
8 training programs, and all interest earned on the ~~moneys~~ MONEY ~~shall~~
9 MUST be deposited in the state treasury in the fire service education and
10 training fund, REFERRED TO IN THIS SECTION AS THE "FUND", which fund
11 is hereby created, and except as otherwise specified in SUBSECTION (3) OF
12 THIS SECTION, the ~~moneys~~ MONEY IN THE FUND ~~shall~~ MUST be used,
13 subject to annual appropriations by the general assembly, for the purposes
14 set forth in this part 12 and shall not be deposited in or transferred to the
15 general fund of the state of Colorado or any other fund.

16 (3) (a) ON THE EFFECTIVE DATE OF THIS SUBSECTION (3), THE
17 STATE TREASURER SHALL TRANSFER SEVEN HUNDRED SIXTY THOUSAND
18 DOLLARS FROM THE GENERAL FUND TO THE FUND. THE DIVISION SHALL
19 USE THE MONEY TRANSFERRED PURSUANT TO THIS SUBSECTION (3)(a) TO
20 PURCHASE A MOBILE DRIVER SIMULATOR UNIT TO BE USED FOR TRAINING
21 PURPOSES CONDUCTED BY THE DIVISION THROUGHOUT THE STATE. THE
22 MOBILE DRIVER SIMULATOR UNIT IS DEDICATED IN THE MEMORY OF
23 CAPTAIN DARCY STALLINGS.

24 (b) ON JULY 1, 2023, AND ON EVERY JULY 1 THEREAFTER, THE
25 STATE TREASURER SHALL TRANSFER ONE HUNDRED EIGHTY-FIVE
26 THOUSAND DOLLARS FROM THE GENERAL FUND TO THE FUND. THE
27 DIVISION SHALL USE THE MONEY TRANSFERRED PURSUANT TO THIS
28 SUBSECTION (3)(b) FOR THE OPERATIONAL COSTS, INCLUDING PERSONNEL
29 COSTS, ASSOCIATED WITH THE USE OF THE MOBILE DRIVER SIMULATOR
30 UNIT.

31 (c) MONEY IN THE FUND IS CONTINUOUSLY APPROPRIATED TO THE
32 DIVISION FOR THE PURPOSES SPECIFIED IN THIS SUBSECTION (3).".
