Committee on Education.

HB25-1210 be amended as follows:

1 Amend printed bill, page 6, strike lines 11 through 27 and substitute:

2       **"SECTION 4.** In Colorado Revised Statutes, 22-11-210, **amend**  
3 (2)(a) as follows:

4       **22-11-210. Public schools - annual review - plans - supports**  
5 **and interventions - rules.** (2) (a) The department shall annually review  
6 each public school's performance and, based on the rules of the state  
7 board, recommend to the state board that the public school shall  
8 implement a performance, improvement, priority improvement, or  
9 turnaround plan for the coming school year. Based on the department's  
10 recommendation, the state board shall notify the local school board for  
11 the public school, or the institute if the public school is an institute charter  
12 school, regarding the type of plan the public school shall implement. The  
13 local school board or the institute shall place the public school in the  
14 district or institute accreditation category that correlates to the public  
15 school's plan, based on the school district's or institute's school  
16 accreditation process. THE DEPARTMENT SHALL DEVELOP A STREAMLINED  
17 FORMAT FOR PLANS THAT CONSOLIDATES VARIOUS STATE, FEDERAL, AND  
18 GRANT REPORTING REQUIREMENTS AND ALLOWS A LOCAL SCHOOL BOARD  
19 FOR THE PUBLIC SCHOOL, OR THE INSTITUTE IF THE PUBLIC SCHOOL IS AN  
20 INSTITUTE CHARTER SCHOOL, TO ATTACH A LOCALLY-DEVELOPED ACTION  
21 PORTION OF THE PLAN THAT ADDRESSES ACTION STEPS, RESOURCES, AND  
22 ANY OTHER PLAN COMPONENTS IDENTIFIED IN STATE BOARD RULE. THE  
23 DEPARTMENT SHALL MAINTAIN A CENTRALIZED SYSTEM FOR PLAN  
24 SUBMISSIONS SO THE DEPARTMENT CAN CONDUCT A STATEWIDE ANALYSIS  
25 OF PUBLIC SCHOOL PLANS IN ORDER TO DETERMINE HOW TO BEST  
26 DISTRIBUTE STATE RESOURCES AND SUPPORTS. ON OR BEFORE AUGUST 1,  
27 2025, AND REGULARLY THEREAFTER, THE DEPARTMENT MUST COLLECT  
28 USER FEEDBACK TO ASSESS THE EXTENT TO WHICH THE STREAMLINED  
29 FORMAT FOR PLANS IS USED, WHETHER IT IS HELPFUL, AND HOW TO USE  
30 THIS FEEDBACK TO IMPROVE THE CENTRALIZED SYSTEM.".
