- 1 Amend printed bill, page 5, after line 2 insert:
"SECTION 2. In Colorado Revised Statutes, 10-16-1206, **amend**
3 (1)(e) and (1)(f); and **add** (1)(g) as follows:
10-16-1206. Health insurance affordability cash fund -
5 **creation.** (1) There is hereby created in the state treasury the health
6 insurance affordability cash fund. The fund consists of:
7 (e) Money that may be allocated to the fund pursuant to section
8 10-16-1308; **and**
9 (f) All interest and income derived from the deposit and
10 investment of money in the fund; **AND**
11 (g) THE FEDERAL SHARE OF THE MEDICAL ASSISTANCE PAYMENTS
12 RECEIVED PURSUANT TO SECTION 25.5-4-503 (2).".
- 13 Renumber succeeding sections accordingly.
- 14 Page 23, line 5, after "SUPPORTS." insert "THE DEPARTMENT SHALL
15 REPORT ON THE ESTABLISHED PRIORITIES AND BUDGET ALLOCATIONS AND
16 THE WAYS IN WHICH THEY ARE INCLUSIVE OF STAKEHOLDER INPUT DURING
17 THE DEPARTMENT'S 2024 PRESENTATION TO THE JOINT BUDGET
18 COMMITTEE OF THE GENERAL ASSEMBLY AND IN THE DEPARTMENT'S
19 PRESENTATION TO THE HEALTH AND HUMAN SERVICES COMMITTEE OF THE
20 SENATE AND THE HEALTH AND INSURANCE COMMITTEE OF THE HOUSE OF
21 REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES, AT THE HEARING
22 HELD PURSUANT TO SECTION 2-7-203 (2)(a) OF THE "STATE
23 MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT
24 (SMART) GOVERNMENT ACT".".
- 25 Page 23, after line 17 insert:
26 "(d) CONDUCT A MINIMUM OF FIVE STAKEHOLDER MEETINGS AND
27 CONDUCT ADDITIONAL MEETINGS FOCUSED ON HEARING INPUT FROM
28 INDIVIDUAL CONSTITUENCIES LISTED IN SUBSECTION (2)(a) OF THIS
29 SECTION.".
- 30 Reletter succeeding paragraphs accordingly.
