Committee on Public & Behavioral Health & Human Services.

HB22-1289 be amended as follows:

- 1 Amend printed bill, page 17, strike lines 7 through 9 and substitute
2 "SUPPORT SERVICES, LACTATION SUPPLIES AND EQUIPMENT, AND
3 MAINTENANCE OF MULTI-USER LOANED EQUIPMENT. AN INDIVIDUAL
4 TRAINED IN ADVANCED LACTATION SUPPORT SHALL PROVIDE THE
5 LACTATION SUPPORT SERVICES. LACTATION EQUIPMENT MUST INCLUDE A
6 SINGLE-USER DOUBLE ELECTRIC BREAST PUMP, PUMP PARTS AND PUMP
7 COLLECTION KIT, AND ACCESS TO A LOANED MULTI-USER HOSPITAL GRADE
8 ELECTRIC BREAST PUMP ALONG WITH A COMPATIBLE INDIVIDUAL
9 COLLECTION KIT. INDIVIDUALS MUST HAVE ACCESS TO SINGLE-USER
10 LACTATION SUPPLIES AND EQUIPMENT PRIOR TO DELIVERY. ACCESS TO
11 MULTI-USER LOANED BREAST PUMPS SHALL BE AUTHORIZED BY A
12 HEALTH-CARE PROVIDER. ACCESS TO MULTI-USER LOANED BREAST PUMPS
13 IS PRIORITIZED FOR INDIVIDUALS WITH PREMATURE, MEDICALLY FRAGILE,
14 LOW BIRTH WEIGHT INFANTS, AND WITH LACTATION COMPLICATIONS.
15 INDIVIDUALS CANNOT BE REQUIRED TO ENROLL IN SEPARATE OR
16 ADDITIONAL PROGRAMS IN ORDER TO RECEIVE COVERED LACTATION
17 EQUIPMENT OR LACTATION SUPPORT SERVICES.".
- 18 Page 19, line 10, strike "BREASTFEEDING".
- 19 Page 19, strike lines 11 through 13 and substitute "LACTATION SUPPLIES
20 AND EQUIPMENT, AND MAINTENANCE OF MULTI-USER LOANED EQUIPMENT.
21 AN INDIVIDUAL TRAINED IN ADVANCED LACTATION SUPPORT SHALL
22 PROVIDE THE LACTATION SUPPORT SERVICES. LACTATION EQUIPMENT
23 MUST INCLUDE A SINGLE-USER DOUBLE ELECTRIC BREAST PUMP, PUMP
24 PARTS AND PUMP COLLECTION KIT, AND ACCESS TO A LOANED MULTI-USER
25 HOSPITAL GRADE ELECTRIC BREAST PUMP ALONG WITH A COMPATIBLE
26 INDIVIDUAL COLLECTION KIT. INDIVIDUALS MUST HAVE ACCESS TO
27 SINGLE-USER LACTATION SUPPLIES AND EQUIPMENT PRIOR TO DELIVERY.
28 ACCESS TO MULTI-USER LOANED BREAST PUMPS SHALL BE AUTHORIZED BY
29 A HEALTH-CARE PROVIDER. ACCESS TO MULTI-USER LOANED BREAST
30 PUMPS IS PRIORITIZED FOR INDIVIDUALS WITH PREMATURE, MEDICALLY
31 FRAGILE, LOW BIRTH WEIGHT INFANTS, AND WITH LACTATION
32 COMPLICATIONS. INDIVIDUALS CANNOT BE REQUIRED TO ENROLL IN
33 SEPARATE OR ADDITIONAL PROGRAMS IN ORDER TO RECEIVE COVERED
34 LACTATION EQUIPMENT OR LACTATION SUPPORT SERVICES.".
