1 Amend printed bill, page 12, strike lines 2 through 7 and substitute
2 **"treatment on life or health insurance. AN INSURER MAY NOT REFUSE**
3 **TO INSURE, REFUSE TO CONTINUE TO INSURE, OR LIMIT THE AMOUNT,**
4 **EXTENT, OR KIND OF COVERAGE AVAILABLE FOR LIFE INSURANCE, HEALTH**
5 **INSURANCE, OR WITHIN AN ANNUITY TO AN INDIVIDUAL, OR CHARGE AN**
6 **INDIVIDUAL A DIFFERENT RATE FOR THE SAME COVERAGE, SOLELY**
7 **BECAUSE SUCH INDIVIDUAL EXECUTED A BEHAVIORAL HEALTH ORDERS**
8 **FORM OR HAS NOT EXECUTED A BEHAVIORAL HEALTH ORDERS FORM. WITH**
9 **RESPECT TO ALL OTHER CONDITIONS, PERSONS WHO HAVE EXECUTED A**
10 **BEHAVIORAL HEALTH ORDERS FORM MUST BE SUBJECT TO THE SAME**
11 **STANDARDS OF SOUND ACTUARIAL PRINCIPLES OR ACTUAL OR**
12 **REASONABLY ANTICIPATED EXPERIENCE AS ARE PERSONS WHO HAVE NOT**
13 **EXECUTED A BEHAVIORAL HEALTH ORDERS FORM.".**

14 Page 12, after line 20, insert:

15 **"SECTION 5.** In Colorado Revised Statutes, **amend 15-18.7-109**
16 as follows:

17 **15-18.7-109. Effect of a medical orders for scope of treatment**
18 ~~**form on life or health insurance. Neither a medical orders for scope of**~~
19 ~~**treatment form nor the failure of an adult to execute a medical orders for**~~
20 ~~**scope of treatment form shall affect, impair, or modify a contract of life**~~
21 ~~**or health insurance or an annuity or be the basis for a delay in issuing or**~~
22 ~~**refusal to issue an annuity or policy of life or health insurance or for any**~~
23 ~~**increase of a premium therefor**~~ AN INSURER MAY NOT REFUSE TO INSURE,
24 REFUSE TO CONTINUE TO INSURE, OR LIMIT THE AMOUNT, EXTENT, OR KIND
25 OF COVERAGE AVAILABLE FOR LIFE INSURANCE, HEALTH INSURANCE, OR
26 WITHIN AN ANNUITY TO AN INDIVIDUAL, OR CHARGE AN INDIVIDUAL A
27 DIFFERENT RATE FOR THE SAME COVERAGE, SOLELY BECAUSE SUCH
28 INDIVIDUAL EXECUTED A MEDICAL ORDERS FOR SCOPE OF TREATMENT
29 FORM OR HAS NOT EXECUTED A MEDICAL ORDERS FOR SCOPE OF
30 TREATMENT FORM. WITH RESPECT TO ALL OTHER CONDITIONS, PERSONS
31 WHO HAVE EXECUTED A MEDICAL ORDERS FOR SCOPE OF TREATMENT
32 FORM MUST BE SUBJECT TO THE SAME STANDARDS OF SOUND ACTUARIAL
33 PRINCIPLES OR ACTUAL OR REASONABLY ANTICIPATED EXPERIENCE AS ARE
34 PERSONS WHO HAVE NOT EXECUTED A MEDICAL ORDERS FOR SCOPE OF
35 TREATMENT FORM.".
