

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB19-1269 be amended as follows:

1 Amend the Public Health Care and Human Services Committee Report,  
2 dated April 5, 2019, page 3, strike lines 22 through 30 and substitute:

3 "Page 16 of the printed bill, lines 4 and 5, strike "**provisions. (4)**" and  
4 substitute "**provisions - rules. (4) (a)**".

6 Page 16 of the bill, strike line 15 and substitute "BOARD SHALL  
7 ESTABLISH, BY RULE, A PROCEDURE TO ALLOW FOR REIMBURSEMENT OF  
8 MEDICALLY NECESSARY STATE PLAN SERVICES UNDER".

9 Page 16 of the bill, lines 16 and 17, strike "PROGRAM THROUGH A  
10 PROCEDURE ESTABLISHED BY STATE BOARD RULE." and substitute  
11 "PROGRAM.".

12 Page 16 of the bill, after line 18 insert:

13 " (b) THE STATE BOARD SHALL ADOPT RULES ESTABLISHING THE  
14 PROCEDURES FOR REIMBURSEMENT PURSUANT TO THIS SUBSECTION (4) BY  
15 JANUARY 1, 2020.".

16 Page 16 of the bill, line 20, strike "and (16)" and substitute "(16), and  
17 (17)".

18 Page 16 of the bill, line 21, strike "**definition.**" and substitute "**definition**  
19 **- rules.**".

20 Page 17 of the bill, strike line 4 and substitute "A REASONABLE PERIOD  
21 WHERE MEDICALLY NECESSARY".

22 Page 17 of the bill, line 5, strike "MEDICALLY NECESSARY,", and strike  
23 INTERVALS;" and substitute "INTERVALS, AS DETERMINED BY STATE  
24 BOARD RULE;".

25 Page 17 of the bill, strike lines 10 through 17 and substitute "SERVICE;  
26 AND

27 (i) REQUIRE AN MCE TO COVER ALL MEDICALLY NECESSARY  
28 COVERED TREATMENTS FOR COVERED BEHAVIORAL HEALTH DIAGNOSES,  
29 REGARDLESS OF ANY CO-OCCURRING CONDITIONS.

30 (15) ON OR BEFORE JULY 1, 2020, THE STATE DEPARTMENT SHALL  
31 INCLUDE UTILIZATION MANAGEMENT GUIDELINES FOR THE MCEs IN THE  
32 STATE BOARD'S MANAGED CARE RULES.".

- 2    Page 4 of the committee report, strike line 1 and substitute:
  - 3    "Page 17 of the bill, line 18, strike "MAKE EACH MCE ANNUAL" and  
4    substitute "PROVIDE INFORMATION ON ITS WEBSITE SPECIFYING HOW THE  
5    PUBLIC MAY REQUEST THE".
  - 6    Page 17 of the bill, line 19, strike "PUBLIC." and substitute "AND  
7    QUARTERLY NETWORK REPORTS FOR AN MCE.". ".
- 8    Page 4 of the committee report, after line 3 insert:
  - 9    "Page 18 of the bill, line 1, strike "THE" and substitute "IF THE", and  
10    strike "SHALL EXAMINE ALL COMPLAINTS" and substitute "RECEIVES A  
11    COMPLAINT".
  - 12    Page 18 of the bill, line 4, strike "RELATE" and substitute "RELATES", and  
13    strike "OR (15)".
  - 14    Page 18 of the bill, line 5, strike "MHPAEA" and substitute "MHPAEA,  
15    THE STATE DEPARTMENT SHALL EXAMINE THE COMPLAINT, AS REQUESTED  
16    BY THE OFFICE, ".
  - 17    Page 18 of the bill, line 6, strike "REGARDING" and substitute "ANY".
  - 18    Page 18 of the bill, lines 6 and 7, strike "THESE COMPLAINTS." and  
19    substitute "THE COMPLAINT.". ".
- 20    Page 4 of the committee report, strike lines 10 through 18.
- 21    Page 4 of the committee report, after line 25 insert:
  - 22    "Page 23 of the bill, after line 6 insert:
    - 23    "(4) THE STATE DEPARTMENT SHALL CONTRACT WITH AN  
24    EXTERNAL QUALITY REVIEW ORGANIZATION AT LEAST ANNUALLY TO  
25    MONITOR MCES' UTILIZATION MANAGEMENT PROGRAMS AND POLICIES,  
26    INCLUDING THOSE THAT GOVERN ADVERSE DETERMINATIONS, TO ENSURE  
27    COMPLIANCE WITH THE MHPAEA. THE QUALITY REVIEW REPORT MUST  
28    BE READILY AVAILABLE TO THE PUBLIC.". ".
