

SB19-139 be amended as follows:

1 Amend printed bill, page 2, strike lines 16 through 22 and substitute:

2       **"SECTION 2. Appropriation.** For the 2019-20 state fiscal year,  
3 \$1,737,800 is appropriated to the department of revenue. This  
4 appropriation is from the licensing services cash fund created in section  
5 42-2-114.5 (1), C.R.S., and is based on an assumption that the department  
6 will require an additional 21.6 FTE. To implement this act, the  
7 department may use this appropriation as follows:
