HOUSE FLOOR AMENDMENT

Second Reading

BY REPRESENTATIVES Garnett and Duran

- 1 Amend reengrossed bill, page 16, line 22, strike "THE APPLICABLE" and
2 substitute "A".
- 3 Page 16, line 23, strike "PARTICIPATE IN" and substitute "ARE MEMBERS
4 OF A MULTI-EMPLOYER TRADE ASSOCIATION THAT SPONSORS".
- 5 Page 16, line 26, after "OR" insert "DIRECTLY SPONSOR SUCH A PROGRAM
6 FOR THEIR OWN EMPLOYEES, SHALL PAY THE DETERMINED
7 APPRENTICESHIP CONTRIBUTION TO THAT PROGRAM OR TO".
- 8 Page 16, line 27, strike "LABOR SHALL PAY THE DETERMINED" and
9 substitute "LABOR; OR".
- 10 Page 17, strike line 1.
- 11 Page 17, line 2, strike "CONTRACTORS" and substitute "EXCEPT AS
12 OTHERWISE PROVIDED IN SUBSECTION (5) OF THIS SECTION,
13 CONTRACTORS".
- 14 Page 17, after line 10 insert:
 - 15 "(4) TO THE EXTENT FEASIBLE, THE DEPARTMENT OF PERSONNEL
16 SHALL PUBLISH AN ANNUAL REPORT DETAILING THE AMOUNT OF
17 APPRENTICESHIP TRAINING CONTRIBUTION PAID PURSUANT TO
18 SUBSECTIONS (2)(a), (2)(b), AND (2)(c) OF THIS SECTION FROM
19 INFORMATION REPORTED BY THE CONTRACTING AGENCIES OF
20 GOVERNMENT.
 - 21 (5) IF THE DATA TRACKED BY THE DEPARTMENT OF PERSONNEL
22 DEMONSTRATES THAT PORTIONS OF THE APPRENTICE CONTRIBUTIONS
23 REQUIRED PURSUANT TO SUBSECTION (2) OF THIS SECTION ARE PAID UNDER
24 THE REQUIREMENTS OF SUBSECTION (2)(c) OF THIS SECTION AT A HIGHER
25 RATE THAN UNDER THE REQUIREMENTS OF SUBSECTION (2)(a) OR (2)(b) OF
26 THIS SECTION, THE DEPARTMENT MAY PROMULGATE RULES FOR
27 ALTERNATIVES TO THE REQUIREMENTS SUBSECTION (2)(c) OF THIS
28 SECTION.".
