SB19-224 be amended as follows:

- 1 Amend printed bill, page 93, after line 3 insert:
2 **"SECTION 38.** In Colorado Revised Statutes, **add 44-11-902** as
3 follows:
4 **44-11-902. Unlawful open and public consumption.** (1) THE
5 OPEN AND PUBLIC, AS DEFINED IN SECTION 18-18-102 (20.3),
6 CONSUMPTION OF MARIJUANA IS PROHIBITED.
7 (2) THE GOVERNING BODY OF A COUNTY, CITY, CITY AND COUNTY,
8 OR MUNICIPALITY MAY ADOPT AN ORDINANCE OR RESOLUTION
9 AUTHORIZING MARIJUANA CONSUMPTION LOCATIONS OR CIRCUMSTANCES
10 THAT ARE EXCEPTIONS TO THE PROHIBITION DESCRIBED IN SUBSECTION (1)
11 OF THIS SECTION IF THE LOCATIONS ARE NOT ACCESSIBLE TO THE PUBLIC

26 (2) THE GOVERNING BODY OF A COUNTY, CITY, CITY AND COUNTY,
27 OR MUNICIPALITY MAY ADOPT AN ORDINANCE OR RESOLUTION
28 AUTHORIZING MARIJUANA CONSUMPTION LOCATIONS OR CIRCUMSTANCES

3 "**SECTION 47.** In Colorado Revised Statutes, 18-18-102, **add**
4 (20.3) as follows:
5 **18-18-102. Definitions.** As used in this article 18:
6 (20.3) (a) "OPEN" OR "OPENLY" MEANS OBSERVABLE BY THE
7 PUBLIC OR A SUBSTANTIAL NUMBER OF THE PUBLIC.
8 (b) "PUBLIC" OR "PUBLICLY" MEANS A PLACE TO WHICH THE
9 PUBLIC OR A SUBSTANTIAL NUMBER OF THE PUBLIC HAS ACCESS WITHOUT
10 RESTRICTION, INCLUDING BUT NOT LIMITED TO STREETS AND HIGHWAYS,
11 TRANSPORTATION FACILITIES, PLACES OF AMUSEMENT, PARKS,
12 PLAYGROUNDS, AND THE COMMON AREAS OF BUILDINGS AND OTHER
13 FACILITIES.
14 (c) "OPEN AND PUBLIC" OR "OPENLY AND PUBLICLY" DOES NOT
15 INCLUDE ANY ACTIVITY OCCURRING ON PRIVATE RESIDENTIAL PROPERTY
16 BY THE OCCUPANT OR HIS OR HER GUESTS.

18 Page 227, after line 7 insert:
19 "**44-10-702. Unlawful open and public consumption.** (1) THE
20 OPEN AND PUBLIC, AS DEFINED IN SECTION 18-18-102 (20.3),
21 CONSUMPTION OF MARIJUANA IS PROHIBITED.
22 (2) THE GOVERNING BODY OF A COUNTY, CITY, CITY AND COUNTY,
23 OR MUNICIPALITY MAY ADOPT AN ORDINANCE OR RESOLUTION
24 AUTHORIZING MARIJUANA CONSUMPTION LOCATIONS OR CIRCUMSTANCES
25 THAT ARE EXCEPTIONS TO THE PROHIBITION DESCRIBED IN SUBSECTION (1)
26 OF THIS SECTION IF THE LOCATIONS ARE NOT ACCESSIBLE TO THE PUBLIC
