SB19-259 be amended as follows:

- 1 Amend reengrossed bill, page 3, after line 23 insert:  
**"SECTION 2.** In Colorado Revised Statutes, 17-27-103, **add** (11)  
2 as follows:  
**17-27-103. Community corrections boards - establishment -**  
3 **duties.** (11) NOTWITHSTANDING THE PROVISIONS OF THIS SECTION, A  
4 COMMUNITY CORRECTIONS BOARD HAS NO AUTHORITY TO ACCEPT OR  
5 REJECT PARTICIPANTS IN THE DEPARTMENT OF CORRECTIONS INTENSIVE  
6 SUPERVISION PROGRAM OPERATED PURSUANT TO SECTION 17-27.5-101.  
7 **SECTION 3.** In Colorado Revised Statutes, 17-27.5-101, **amend**  
8 (1)(a) and (1)(c) as follows:  
**17-27.5-101. Authority to establish intensive supervision**  
9 **programs for parolees and community corrections offenders.**  
10 (1) (a) The department ~~shall have~~ HAS the authority to establish and  
11 directly operate an intensive supervision program for any offender not  
12 having more than one hundred eighty days remaining until such offender's  
13 parole eligibility date and for any offender who successfully completes a  
14 regimented inmate discipline program pursuant to article 27.7 of this ~~title~~  
15 ~~TITLE 17. THE DEPARTMENT'S INTENSIVE SUPERVISION PROGRAM IS NOT A~~  
16 COMMUNITY CORRECTIONS PROGRAM.  
17 (c) The department ~~shall have~~ HAS the authority to contract with  
18 community corrections programs and other providers for intensive  
19 supervision services subject to the approval of the affected unit of local  
20 government. In contracting for such programs, the department shall  
21 obtain the advice and consent of affected units of local government and  
22 shall consider the needs of the communities and offenders for successful  
23 reintegration into communities and the appropriate allocation of resources  
24 for effective correction of offenders. ~~THE LOCAL COMMUNITY~~  
25 ~~CORRECTIONS BOARD HAS THE AUTHORITY TO ACCEPT, REJECT, OR REJECT~~  
26 ~~AFTER ACCEPTANCE THE PARTICIPATION OF ANY OFFENDER IN EACH~~
