PURPOSE: Increases cash fund appropriations from the Marijuana Tax Cash Fund by a total of \$7,696,200, including: \$200,000 to the Department of **Health Care Policy and Financing**; \$1,500,000 to the Department of **Higher Education**; \$966,757 to the Department of **Human Services**; and \$5,029,443 to the Department of **Public Health and Environment**.
