8 Page 412, line 13, strike "This amount" and substitute "Of this amount,  
9 \$50,000" and strike "C.R.S." and substitute "C.R.S., and \$29,443 shall be  
10 from the Marijuana Tax Cash Fund created in Section 39-28.8-501 (1),  
11 C.R.S.".

**PURPOSE:** Increases cash fund appropriations from the Marijuana Tax Cash Fund by a total of \$7,696,200, including: \$200,000 to the Department of **Health Care Policy and Financing**; \$1,500,000 to the Department of **Higher Education**; \$966,757 to the Department of **Human Services**; and \$5,029,443 to the Department of **Public Health and Environment**.
