SB26-030 be amended as follows:

1 Amend printed bill, page 5, after line 19 add:

2 "SECTION 3. In Colorado Revised Statutes, 2-3-1203, **add** (27)  
3 as follows:

4 **2-3-1203. Sunset review of advisory committees - legislative**  
5 **declaration - definition - repeal.**

6 (27) (a) THE FOLLOWING STATUTORY AUTHORIZATIONS FOR THE  
7 DESIGNATED ADVISORY COMMITTEES WILL REPEAL ON SEPTEMBER 1,  
8 2036:

9 (I) THE STATE PARK AND STATE WILDLIFE AREA ACCESS ADVISORY  
10 BOARD CREATED IN SECTION 24-32-136 (3).

11 (b) THIS SUBSECTION (27) IS REPEALED, EFFECTIVE SEPTEMBER 1,  
12 2038."

13 Renumber succeeding sections accordingly.

14 Page 5, line 23, after "**creation -**" insert "**advisory board -**".

15 Page 6, line 2, strike "(5)" and substitute "(6)".

16 Page 6, after line 6 insert:

17 "(e) "STATE PARK AND STATE WILDLIFE AREA ACCESS ADVISORY  
18 BOARD" OR "ADVISORY BOARD" MEANS THE STATE PARK AND STATE  
19 WILDLIFE AREA ACCESS ADVISORY BOARD CREATED IN SUBSECTION (3) OF  
20 THIS SECTION."

21 Page 7, line 3, strike "THE" and substitute "IN CONSULTATION WITH THE  
22 ADVISORY BOARD, THE".

23 Page 7, strike lines 5 and 6 and substitute "PAID OUT OF THE FUND."

24 Page 7, after line 10 insert:

25 "(3) **State park and state wildlife area access advisory board**  
26 **- creation - membership - powers and duties - compensation - subject**  
27 **to review - repeal.**

28 (a) THERE IS CREATED THE STATE PARK AND STATE WILDLIFE  
29 AREA ACCESS ADVISORY BOARD TO CONSIDER AND MAKE  
30 RECOMMENDATIONS TO THE DIVISION ABOUT GRANT AWARD  
31 APPLICATIONS AND OTHER ISSUES REGARDING THE STATE PARK AND STATE

1 WILDLIFE AREA ACCESS GRANT PROGRAM.

2 (b) (I) THE ADVISORY BOARD CONSISTS OF FIVE MEMBERS WHO  
3 ARE APPOINTED BY THE DIRECTOR OF THE DIVISION AND WHO MUST BE  
4 MEMBERS OF A STATEWIDE ASSOCIATION THAT REPRESENTS COUNTY  
5 COMMISSIONERS.

6 (II) ON OR BEFORE FEBRUARY 1, 2027, AND ON OR BEFORE  
7 FEBRUARY 1 OF EVERY ODD-NUMBERED YEAR THEREAFTER, THE DIRECTOR  
8 OF THE DIVISION SHALL APPOINT MEMBERS TO THE ADVISORY BOARD. IN  
9 MAKING THE APPOINTMENTS, THE DIRECTOR SHALL ENSURE GEOGRAPHIC  
10 DIVERSITY IN THE ADVISORY BOARD MEMBERSHIP.

11 (III) BEFORE INITIALLY APPOINTING MEMBERS TO THE ADVISORY  
12 BOARD, THE DIRECTOR OF THE DIVISION SHALL CONSULT WITH AND  
13 CONSIDER THE APPOINTMENT RECOMMENDATIONS PROVIDED BY THE  
14 STATEWIDE ASSOCIATION IDENTIFIED IN SUBSECTION (3)(b)(I) OF THIS  
15 SECTION.

16 (IV) IN THE EVENT OF A VACANCY OR VACANCIES IN THE  
17 MEMBERSHIP OF THE ADVISORY BOARD, THE DIRECTOR OF THE DIVISION  
18 SHALL:

19 (A) FOR EACH VACANCY, APPOINT AN INDIVIDUAL WHO IS A  
20 MEMBER OF THE STATEWIDE ASSOCIATION IDENTIFIED IN SUBSECTION  
21 (3)(b)(I) OF THIS SECTION AND WHO IS FROM THE SAME GEOGRAPHIC  
22 REGION REPRESENTED BY THE INDIVIDUAL WHO PREVIOUSLY HELD THE  
23 SEAT ON THE ADVISORY BOARD; AND

24 (B) BEFORE MAKING AN APPOINTMENT TO FILL A VACANCY,  
25 CONSULT WITH AND CONSIDER THE APPOINTMENT RECOMMENDATIONS  
26 PROVIDED BY THE ADVISORY BOARD; EXCEPT THAT, IF THERE ARE FEWER  
27 THAN THREE MEMBERS REMAINING ON THE ADVISORY BOARD, THE  
28 DIRECTOR OF THE DIVISION SHALL CONSULT WITH AND CONSIDER THE  
29 APPOINTMENT RECOMMENDATIONS PROVIDED BY THE STATEWIDE  
30 ASSOCIATION IDENTIFIED IN SUBSECTION (3)(b)(I) OF THIS SECTION.

31 (c) (I) THE ADVISORY BOARD SHALL SERVE IN AN ADVISORY  
32 CAPACITY TO THE DIVISION REGARDING THE STATE PARK AND STATE  
33 WILDLIFE AREA ACCESS GRANT PROGRAM. THE ADVISORY BOARD MAY  
34 MAKE RECOMMENDATIONS TO THE DIVISION ON ANY MATTER RELATING TO  
35 THE GRANT PROGRAM.

36 (II) THE DIVISION SHALL CONSULT WITH AND CONSIDER THE  
37 RECOMMENDATIONS OF THE ADVISORY BOARD ON MATTERS RELATING TO  
38 THE STATE PARK AND STATE WILDLIFE AREA ACCESS GRANT PROGRAM,  
39 INCLUDING WHEN:

40 (A) IMPLEMENTING AND ADMINISTERING THE GRANT PROGRAM IN  
41 ACCORDANCE WITH THIS SECTION;

42 (B) AFTER THE INITIAL APPOINTMENTS HAVE BEEN MADE,  
43 APPOINTING MEMBERS TO THE ADVISORY BOARD;

44 (C) DETERMINING THE FORM AND MANNER OF A GRANT  
45 APPLICATION;

1 (D) DEVELOPING CRITERIA FOR AWARDING GRANTS;  
2 (E) REVIEWING AND EVALUATING GRANT APPLICATIONS; AND  
3 (F) AWARDING GRANTS.

4 (d) MEMBERS OF THE ADVISORY BOARD SERVE WITHOUT  
5 COMPENSATION.

6 (e) THIS SUBSECTION (3) IS REPEALED, EFFECTIVE SEPTEMBER 1,  
7 2036. BEFORE THE REPEAL, THE ADVISORY BOARD IS SCHEDULED FOR  
8 REVIEW IN ACCORDANCE WITH SECTION 2-3-1203."

9 Renumber succeeding subsections accordingly.

10 Page 7, line 14, strike "THE" and substitute:

11 "AFTER CONSULTING WITH AND CONSIDERING RECOMMENDATIONS  
12 MADE BY THE ADVISORY BOARD, THE".

13 Page 7, line 16, after "SHALL" insert "PROVIDE A COPY OF EACH  
14 APPLICATION THE DIVISION RECEIVES TO THE ADVISORY BOARD. IN  
15 CONSULTATION WITH THE ADVISORY BOARD, THE DIVISION SHALL".

16 Page 7, lines 18 and 19, strike "STATE PARK AND STATE WILDLIFE AREA  
17 ACCESS CASH".

18 Page 7, line 19, after "AWARD" insert "A GRANT OR".

19 Page 7, line 20, after the period insert "BEFORE AWARDING A GRANT OR  
20 GRANTS, THE DIVISION SHALL CONSULT WITH AND CONSIDER THE  
21 RECOMMENDATIONS REGARDING GRANT AWARDS MADE BY THE ADVISORY  
22 BOARD."

23 Page 7, line 26, after the second "THE" insert "ADVISORY BOARD AND  
24 THE".

25 Page 7, line 27, strike "(4)(b)" and substitute "(5)(b)".

26 Page 8, line 27, strike "(4)(b)" and substitute "(5)(b)".

27 Page 10, line 22, strike "(5);" and substitute "(6);".
