HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture, Water & Natural Resources.

HB26-1008 be amended as follows:

1 Amend printed bill, page 3, after line 17 insert:

2 "(g) Colorado has a long-standing tradition of managing public  
3 lands and working landscapes to support a range of compatible uses and  
4 affirms that coordinated outdoor recreation management can occur  
5 alongside conservation, agricultural operations, and other land uses in  
6 ways that support long-term resource stewardship and community  
7 values;"

8 Reletter succeeding paragraphs accordingly.

9 Page 3, line 25, strike "tribal nations," and substitute "Tribal  
10 governments,".

11 Page 3, line 26, after "data;" insert "advance coordinated planning that  
12 recognizes that Colorado's public and private lands support multiple  
13 uses;"

14 Page 5, line 5, after "landowners," insert "including private landowners  
15 adjacent to outdoor recreation development,".

16 Page 8, line 17, after "WILDLIFE," insert "AGRICULTURAL,".

17 Page 9, line 13, strike "ACCESS" and substitute "ACCESS, AGRICULTURAL  
18 WORKING LANDS,".

19 Page 9, line 18, after "CONSERVATION," insert "AGRICULTURE,".

20 Page 10, line 17, strike "AND".

21 Page 10, strike line 23 and substitute "PROPERTY RIGHTS, AGRICULTURAL  
22 OPERATIONS ON WORKING LANDS, WILDLIFE, AND NATURAL RESOURCES;  
23 AND

24 (c) IN CARRYING OUT THE DUTIES DESCRIBED IN THIS SUBSECTION  
25 (5), APPLY AN INTEGRATED APPROACH THAT CONSIDERS OUTDOOR  
26 RECREATION ACCESS, VISITOR USE MANAGEMENT, CONSERVATION,  
27 WILDLIFE HABITAT, WORKING LANDS, AND LONG-TERM RESOURCE  
28 STEWARDSHIP SO THAT THESE USES, TAKEN TOGETHER, BEST MEET  
29 PRESENT AND FUTURE NEEDS WITHOUT PERMANENT IMPAIRMENT OF THE  
30 PRODUCTIVITY OR HEALTH OF THE STATE'S NATURAL RESOURCES, TO THE  
31 EXTENT PRACTICABLE AND CONSISTENT WITH STATE LAW."

1 Page 13, line 4, strike "OR".

2 Page 13, line 6, strike "JURISDICTION." and substitute "JURISDICTION; OR

3 (c) ALTERS OR DIMINISHES THE DIVISION'S EXISTING STATUTORY  
4 RESPONSIBILITIES TO PERPETUATE THE WILDLIFE RESOURCES OF THE STATE  
5 AND TO MANAGE AND IMPROVE THE STATE PARKS SYSTEM. THE  
6 AUTHORITY SET FORTH IN THIS SECTION COMPLEMENTS THE DIVISION'S  
7 MISSION AND EXISTING OBLIGATIONS."
