

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government & Housing.

SB26-080 be amended as follows:

1 Amend printed bill, page 7, after line 27 insert:

2 "(6) THE STATE DEPARTMENT IS ONLY REQUIRED TO IMPLEMENT
3 SECTIONS 26-25-103 (3), 26-25-103 (4), 26-25-103 (5), 26-25-104,
4 26-25-105, AND 26-25-106 IF THE SECTIONS BECOME EFFECTIVE PURSUANT
5 TO SECTION 26-25-108. THE WORK OF THE STATE DEPARTMENT, THE
6 BOARD, OR ANY OTHER ENTITY CONDUCTED PURSUANT TO THIS ARTICLE
7 25 IS CONTINGENT ON MONEY BEING AVAILABLE TO IMPLEMENT THIS
8 ARTICLE 25."

9 Page 12, line 10, after "(6)" insert "THE STATE DEPARTMENT SHALL BEGIN
10 AWARDING GRANTS PURSUANT TO THIS ARTICLE 25 ONLY AFTER THE
11 BALANCE OF THE FUND REACHES OR EXCEEDS NINE HUNDRED THOUSAND
12 DOLLARS."

13 Page 12, line 27, strike "STATE".

14 Page 13, strike lines 1 through 4 and substitute "BALANCE OF THE FUND
15 REACHES OR EXCEEDS NINE HUNDRED THOUSAND DOLLARS."

16 Page 16, strike line 21 and substitute:

17 **"26-25-108. Effective date - repeal of article - review of**
18 **functions.**

19 (1) SECTIONS 26-25-103 (3), 26-25-103 (4), 26-25-103 (5),
20 26-25-104, 26-25-105, AND 26-25-106 TAKE EFFECT IF THE DEPARTMENT
21 RECEIVES AT LEAST NINE HUNDRED THOUSAND DOLLARS FOR THE
22 PURPOSES OF THIS ARTICLE 25. THE EXECUTIVE DIRECTOR SHALL NOTIFY
23 THE REVISOR OF STATUTES IN WRITING OF THE DATE ON WHICH THE
24 CONDITION SPECIFIED IN THIS SUBSECTION (1) HAS OCCURRED BY
25 EMAILING THE NOTICE TO REVISOROFSTATUTES.GA@COLEG.GOV.
26 SECTIONS 26-25-103 (3), 26-25-103 (4), 26-25-103 (5), 26-25-104,
27 26-25-105, AND 26-25-106 TAKE EFFECT UPON THE DATE IDENTIFIED IN
28 THE NOTICE THAT THE DEPARTMENT HAS RECEIVED AT LEAST NINE
29 HUNDRED THOUSAND DOLLARS FOR THE PURPOSES OF THIS ARTICLE 25 OR,
30 IF THE NOTICE DOES NOT SPECIFY THAT DATE, UPON THE DATE OF THE
31 NOTICE TO THE REVISOR OF STATUTES."

32 Page 16, line 22, before "THIS" insert "(2)".
