Committee on Agriculture, Water & Natural Resources.

HB26-1111 be amended as follows:

- 1 Amend printed bill, page 4, line 15, before the first "PESTICIDE" insert
- 2 "ELIGIBLE".

- 3 Page 4, line 18, strike "AND RECYCLING".

- 4 Page 4, lines 24 and 25, strike "PESTICIDE PRODUCTS OR RECYCLING OF
- 5 PESTICIDE PRODUCT CONTAINERS;" and substitute "ELIGIBLE PESTICIDE
- 6 PRODUCTS;".

- 7 Page 5, line 11, before the first "PESTICIDE" insert "ELIGIBLE".

- 8 Page 6, lines 11 and 12, strike "PESTICIDE PRODUCTS AND THE RECYCLING
- 9 OF MANY OF THE CONTAINERS FOR THE PESTICIDE PRODUCTS" and
- 10 substitute "ELIGIBLE PESTICIDE PRODUCTS".

- 11 Page 8, after line 5 insert:

12 "(7) "ELIGIBLE PESTICIDE PRODUCT" MEANS ALL PESTICIDE
- 13 PRODUCTS REGISTERED IN COLORADO, EXCEPT FOR THOSE THAT HAVE
- 14 BEEN IDENTIFIED AS EXEMPT FROM THE PROGRAM BY THE BOARD
- 15 PURSUANT TO SECTION 35-10.5-104 (2)(b)".

- 16 Renumber succeeding subsections accordingly.

- 17 Page 8, line 27, strike "AND".

- 18 Page 9, line 1, strike "CONTAINER RECYCLING".

- 19 Page 10, line 3, strike "**duties.**" and substitute "**duties - rules.**".

- 20 Page 10, after line 15 insert:

21 "(b) TO ADOPT RULES AS NECESSARY AND NOT INCONSISTENT WITH
- 22 LAW FOR THE ADMINISTRATION AND IMPLEMENTATION OF THIS ARTICLE
- 23 10.5, INCLUDING:
- 24 (I) IDENTIFYING THE PESTICIDE PRODUCTS THAT ARE EXEMPT FROM
- 25 THE PROGRAM BASED ON FACTORS ESTABLISHED BY THE BOARD;
- 26 (II) SETTING THE AMOUNT OF THE PESTICIDE PRODUCT DISPOSAL
- 27 FEE;
- 28 (III) SETTING THE AMOUNT OF THE PESTICIDE REGISTRATION
- 29 PRODUCT DISPOSAL FEE; AND

- 1 (IV) ANY OTHER RULES NECESSARY FOR THE ADMINISTRATION
2 AND IMPLEMENTATION OF THE PROGRAM;".
- 3 Reletter succeeding paragraphs accordingly.
- 4 Page 11, line 4, strike "**fees.**" and substitute "**fees - environmental**
5 **standards.**".
- 6 Page 11, line 7, after "AND" insert "TO COORDINATE".
- 7 Page 11, line 11, strike "PESTICIDE" and substitute "ELIGIBLE PESTICIDE".
- 8 Page 11, strike lines 14 and 15.
- 9 Renumber succeeding subparagraphs accordingly.
- 10 Page 11, line 17, after "DISPOSAL" insert "OF ELIGIBLE PESTICIDE
11 PRODUCTS".
- 12 Page 11, line 18, strike "PESTICIDE PRODUCTS" and substitute "THEIR
13 CONTAINERS".
- 14 Page 12, lines 9 and 10, strike "A PESTICIDE PRODUCT OR RECYCLE A
15 PESTICIDE PRODUCT CONTAINER" and substitute "AN ELIGIBLE PESTICIDE
16 PRODUCT".
- 17 Page 12, strike lines 14 and 15 and substitute "ELIGIBLE PESTICIDE
18 PRODUCT DISPOSAL;".
- 19 Page 12, lines 18 and 19, strike "PESTICIDE PRODUCT OR RECYCLING OF
20 THE PESTICIDE PRODUCT CONTAINER" and substitute "ELIGIBLE PESTICIDE
21 PRODUCT".
- 22 Page 12, strike line 22 and substitute "ELIGIBLE PESTICIDE PRODUCTS".
- 23 Page 12, line 23, strike "DISPOSAL OR RECYCLING." and substitute
24 "DISPOSAL."
- 25 Page 12, line 25, strike the second "A" and substitute "AN ELIGIBLE".
- 26 Page 16, line 9, strike "(1)(a)(IV);" and substitute "(1)(a)(III);".
- 27 Page 16, lines 11 and 12, strike "OR PESTICIDE PRODUCT CONTAINERS
28 THAT WERE RECYCLED".

- 1 Page 16, line 13, strike "(1)(a)(I) AND (1)(a)(II);" and substitute
2 "(1)(a)(I);".
- 3 Page 16, strike line 16 and substitute "(1)(a)(II)".
- 4 Page 16, line 27, strike "35-10.5-102 (13)." and substitute "35-10.5-102
5 (14).".
- 6 Strike "A" and substitute "AN ELIGIBLE" on: **Page 5**, lines 14 and 25; **Page**
7 **6**, line 6; **Page 12**, line 6; and **Page 13**, lines 1, 8, 10, 14, and 18.
- 8 Before "PESTICIDE" insert "ELIGIBLE": on: **Page 3**, line 15; **Page 4**, lines
9 16 and 22; **Page 6**, line 2; **Page 11**, lines 6, 20, and 25; **Page 12**, line 1;
10 and **Page 16**, line 10.
- 11 Strike "AND CONTAINER RECYCLING" on: **Page 5**, lines 24 and 25; **Page**
12 **6**, lines 9, 20, and 23; **Page 7**, line 5; **Page 9**, line 15; **Page 11**, lines 20
13 and 21 and 25 and 26; **Page 13**, lines 14, 20, and 22 and 23; **Page 14**,
14 lines 15 and 16 and 26; and **Page 16**, lines 2, 7, and 26.
