

1 Amend the Rutinel floor amendment (HB1295_L.012), page 3, strike
2 lines 37 through 43 and substitute:

3 **"(II) IF THE CITY AND COUNTY OF DENVER FINDS THAT A MOBILE**
4 **RETAIL FOOD ESTABLISHMENT WITH A STATE HEALTH DEPARTMENT**
5 **LICENSE AND THAT IS OPERATING WITHIN ITS JURISDICTION PURSUANT TO**
6 **SECTION (1)(a) OF THIS SECTION IS IN VIOLATION OF ANY ORDINANCE,**
7 **RESOLUTION, REGULATION, ZONING CODE, HEALTH CODE, OR OTHER CODE**
8 **OF THE CITY AND COUNTY OF DENVER, THE CITY AND COUNTY OF DENVER**
9 **MAY PROHIBIT THE MOBILE RETAIL FOOD ESTABLISHMENT FROM**
10 **OPERATING WITHIN THE CITY AND COUNTY OF DENVER UNTIL THE MOBILE**
11 **RETAIL FOOD ESTABLISHMENT PASSES A HEALTH INSPECTION BY THE CITY**
12 **AND COUNTY OF DENVER OR IS FOUND TO BE IN COMPLIANCE WITH THE**
13 **LAWS OF THE CITY AND COUNTY OF DENVER.".**

14 Page 4, strike line 1.

15 Page 4, strike lines 42 and 43 and substitute:

16 **"(B) IF A LOCAL GOVERNMENT FINDS THAT A MOBILE RETAIL FOOD**
17 **ESTABLISHMENT WITH A DENVER FOOD SAFETY LICENSE AND THAT IS**
18 **OPERATING WITHIN THE LOCAL GOVERNMENT'S JURISDICTION PURSUANT**
19 **TO SUBSECTION (2)(a) OF THIS SECTION IS IN VIOLATION OF THE RULES**
20 **ADOPTED BY THE DEPARTMENT OF PUBLIC HEALTH ENVIRONMENT**
21 **PURSUANT TO SECTION 25-4-1604, THE LOCAL GOVERNMENT MAY**
22 **PROHIBIT THE MOBILE RETAIL FOOD ESTABLISHMENT FROM OPERATING**
23 **WITH THE LOCAL GOVERNMENT'S JURISDICTION UNTIL THE MOBILE RETAIL**
24 **FOOD ESTABLISHMENT PASSES A HEALTH INSPECTION BY THE LOCAL**
25 **GOVERNMENT, THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT,**
26 **OR ANOTHER LOCAL GOVERNMENT THAT ENFORCES THE RULES ADOPTED**
27 **BY THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT PURSUANT TO**
28 **SECTION 25-4-1604.".**

29 Page 5, strike lines 1 through 9.
