

HOUSE FLOOR AMENDMENT

Second Reading

1 Amend the Rutinel floor amendment (HB1295_L.012), page 2, line 29,
2 strike "THREE BUSINESS" and substitute "FOURTEEN CALENDAR".

3 Page 2, after line 36 insert:

4 "(c) A LOCAL GOVERNMENT MAY DESIGNATE THE OFFICE OR
5 DEPARTMENT OF THE LOCAL GOVERNMENT TO WHICH THE OWNER OR
6 OPERATOR OF A MOBILE RETAIL FOOD ESTABLISHMENT SHALL SUBMIT THE
7 COPY OF THE FIRE SAFETY PERMIT IN ACCORDANCE WITH THIS SUBSECTION
8 (2). IF THE LOCAL GOVERNMENT DOES NOT DESIGNATE AN OFFICE OR
9 DEPARTMENT, THE OWNER OR OPERATOR OF THE MOBILE RETAIL FOOD
10 ESTABLISHMENT SHALL SUBMIT THE COPY OF THE FIRE SAFETY PERMIT TO
11 A RELEVANT OFFICE OR DEPARTMENT.".

12 Page 3, line 21, strike "THREE BUSINESS" and substitute "FOURTEEN
13 CALENDAR".

14 Page 3, after line 29 insert:

15 "(III) THE CITY AND COUNTY OF DENVER MAY DESIGNATE THE
16 OFFICE OR DEPARTMENT TO WHICH THE OWNER OR OPERATOR OF A MOBILE
17 RETAIL FOOD ESTABLISHMENT SHALL SUBMIT THE COPY OF THE STATE
18 HEALTH DEPARTMENT LICENSE IN ACCORDANCE WITH THIS SUBSECTION
19 (1)(b). IF THE CITY AND COUNTY OF DENVER DOES NOT DESIGNATE AN
20 OFFICE OR DEPARTMENT, THE OWNER OR OPERATOR OF THE MOBILE RETAIL
21 FOOD ESTABLISHMENT SHALL SUBMIT THE COPY OF THE STATE HEALTH
22 DEPARTMENT LICENSE TO A RELEVANT OFFICE OR DEPARTMENT.".

23 Page 4, line 14, strike "THREE BUSINESS" and substitute "FOURTEEN
24 CALENDAR".

25 Page 4, after line 21 insert:

26 "(III) A LOCAL GOVERNMENT MAY DESIGNATE THE OFFICE OR
27 DEPARTMENT OF THE LOCAL GOVERNMENT TO WHICH THE OWNER OR
28 OPERATOR OF A MOBILE RETAIL FOOD ESTABLISHMENT SHALL SUBMIT THE
29 COPY OF THE DENVER FOOD SAFETY LICENSE IN ACCORDANCE WITH THIS
30 SUBSECTION (2)(b). IF THE LOCAL GOVERNMENT DOES NOT DESIGNATE AN
31 OFFICE OR DEPARTMENT, THE OWNER OR OPERATOR OF THE MOBILE RETAIL
32 FOOD ESTABLISHMENT SHALL SUBMIT THE COPY OF THE DENVER FOOD
33 SAFETY LICENSE TO A RELEVANT OFFICE OR DEPARTMENT.".
