

1 Strike the Transportation, Housing, and Local Government Committee
2 Report, dated March 25, 2025, and substitute:

3 "Amend printed bill, strike everything below the enacting clause and
4 substitute:

5 **"SECTION 1.** In Colorado Revised Statutes, **add 25-4-1618 as**
6 follows:

7 **25-4-1618. Food truck licensing working group - report -**
8 **repeal.** (1) THERE IS CREATED IN THE DEPARTMENT THE FOOD TRUCK
9 LICENSING WORKING GROUP, REFERRED TO IN THIS SECTION AS THE
10 "WORKING GROUP". THE WORKING CONSISTS OF THE FOLLOWING
11 MEMBERS, TO BE APPOINTED BY THE DEPARTMENT:

12 (a) REPRESENTATIVES FROM LOCAL GOVERNMENTS WHO ARE
13 INVOLVED IN THE LICENSING OF FOOD TRUCKS; AND

14 (b) REPRESENTATIVES FROM THE FOOD TRUCK INDUSTRY.

15 (2) (a) THE WORKING GROUP SHALL MEET TO CONSIDER AND
16 PROPOSE A UNIFORM STATEWIDE POLICY FOR THE LICENSING AND
17 PERMITTING OF FOOD TRUCKS THAT PRESERVES LOCAL GOVERNMENT LAND
18 USE AUTHORITY AND LOCAL GOVERNMENT AUTHORITY OVER THE
19 OPERATION OF FOOD TRUCKS.

20 (b) THE WORKING GROUP SHALL SUBMIT A REPORT OF ITS FINDINGS
21 AND THE POLICY PROPOSAL DEVELOPED PURSUANT TO THIS SECTION TO
22 THE GENERAL ASSEMBLY ON OR BEFORE SEPTEMBER 1, 2026.

23 (3) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2027.

24 **SECTION 2. Act subject to petition - effective date.** This act
25 takes effect at 12:01 a.m. on the day following the expiration of the
26 ninety-day period after final adjournment of the general assembly; except
27 that, if a referendum petition is filed pursuant to section 1 (3) of article V
28 of the state constitution against this act or an item, section, or part of this
29 act within such period, then the act, item, section, or part will not take
30 effect unless approved by the people at the general election to be held in
31 November 2026 and, in such case, will take effect on the date of the
32 official declaration of the vote thereon by the governor."..

33 Page 1 of the bill, strike lines 102 through 104 and substitute
34 **"THEREWITH, ESTABLISHING THE FOOD TRUCK LICENSING WORKING**
35 **GROUP TO CONSIDER AND PROPOSE A UNIFORM STATEWIDE POLICY FOR**
36 **THE LICENSING AND PERMITTING OF FOOD TRUCKS.".**
