

HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Transportation, Housing & Local Government.  
HB25-1295 be amended as follows:

1 Amend printed bill, page 8, after line 3 insert:

2       **"(3) Reciprocity between jurisdictions.** (a) THE CITY AND  
3 COUNTY OF DENVER SHALL GRANT A DENVER FOOD SAFETY LICENSE TO  
4 THE OWNER OR OPERATOR OF A MOBILE RETAIL FOOD ESTABLISHMENT IF  
5 THE OWNER OR OPERATOR SUBMITS THE FOLLOWING TO THE CITY AND  
6 COUNTY OF DENVER:

7           (I) AN ACTIVE STATE HEALTH DEPARTMENT LICENSE; AND  
8           (II) PAYMENT OF THE APPLICATION FEE AND LICENSING FEE  
9 CHARGED BY THE CITY AND COUNTY OF DENVER FOR A DENVER FOOD  
10 SAFETY LICENSE IN ACCORDANCE WITH SUBSECTION (3)(c) OF THIS  
11 SECTION.

12          (b) UPON REVIEW OF A RECIPROCAL LICENSE APPLICATION  
13 SUBMITTED IN ACCORDANCE WITH SUBSECTION (3)(a) OF THIS SECTION,  
14 THE CITY AND COUNTY OF DENVER MAY DENY AN OWNER OR OPERATOR  
15 OF A MOBILE RETAIL FOOD ESTABLISHMENT A RECIPROCAL LICENSE  
16 APPLICATION FOR A DENVER FOOD SAFETY LICENSE IF THE OWNER OR  
17 OPERATOR OF THE MOBILE RETAIL FOOD ESTABLISHMENT:

18           (I) HAS NOT OBTAINED OR RENEWED A STATE HEALTH  
19 DEPARTMENT LICENSE WITHIN THE MOST RECENT PAST CALENDAR YEAR;  
20           (II) HAS FAILED AN INSPECTION RELATED TO THE STATE HEALTH  
21 DEPARTMENT LICENSE WITHIN THE MOST RECENT PAST CALENDAR YEAR;  
22 OR

23           (III) HAS OUTSTANDING FEES, FINES, OR PENALTIES IN THE CITY  
24 AND COUNTY OF DENVER OR ANOTHER LOCAL GOVERNMENT  
25 JURISDICTION.

26          (c) (I) THE CITY AND COUNTY OF DENVER MAY CHARGE A  
27 RECIPROCAL LICENSE APPLICATION FEE TO AN OWNER OR OPERATOR OF A  
28 MOBILE RETAIL FOOD ESTABLISHMENT THAT APPLIES FOR A DENVER FOOD  
29 SAFETY LICENSE. THE RECIPROCAL LICENSE APPLICATION FEE MUST NOT  
30 EXCEED THE ADMINISTRATIVE COST INCURRED BY THE CITY AND COUNTY  
31 OF DENVER TO REVIEW THE APPLICATION.

32          (II) THE CITY AND COUNTY OF DENVER MAY CHARGE A  
33 RECIPROCAL LICENSING FEE TO AN OWNER OR OPERATOR OF A MOBILE  
34 RETAIL FOOD ESTABLISHMENT TO OBTAIN A DENVER FOOD SAFETY  
35 LICENSE. THE RECIPROCAL LICENSING FEE MUST NOT EXCEED  
36 TWENTY-FIVE PERCENT OF THE COST OF OBTAINING AN INITIAL DENVER  
37 FOOD SAFETY LICENSE.".
