1 Amend reengrossed bill, page 9, after line 7 add:

2 "SECTION 6. In Colorado Revised Statutes, add 13-14.5-117 as  
3 follows:

4 **13-14.5-117. Data collection - reporting requirement.**

5 (1) UPON ISSUING A TEMPORARY EXTREME RISK PROTECTION  
6 ORDER, AN EXTREME RISK PROTECTION ORDER, OR A TERMINATION OR  
7 RENEWAL OF AN EXTREME RISK PROTECTION ORDER PURSUANT TO THIS  
8 PART 1, THE COURT SHALL COLLECT THE FOLLOWING INFORMATION:

9 (a) FROM A PETITIONER, THE COURT SHALL RECORD:

- 10 (I) THE PETITIONER'S AGE, SEX, AND RACE OR ETHNICITY;
- 11 (II) THE PETITIONER'S RELATIONSHIP WITH THE RESPONDENT; AND
- 12 (III) IF THE PETITIONER ALLEGED THE RESPONDENT USED ALCOHOL  
13 OR DRUGS PRIOR TO THE PETITIONER FILING THE PETITION, AND THE  
14 ALCOHOL OR DRUG USE LED TO THE PETITIONER FILING THE PETITION.

15 (b) FROM A RESPONDENT, THE COURT SHALL RECORD:

- 16 (I) THE RESPONDENT'S COUNTY OF RESIDENCE;
- 17 (II) THE RESPONDENT'S AGE, SEX, AND RACE OR ETHNICITY;
- 18 (III) THE RESPONDENT'S VETERAN, MILITARY, AND MARITAL  
19 STATUS;
- 20 (IV) PRIOR ARRESTS, CONVICTIONS, OR CONCURRENT  
21 PROCEEDINGS THE RESPONDENT IS SUBJECT TO; AND

22 (V) IF A FIREARM IS COLLECTED FROM THE RESPONDENT, THE  
23 FIREARM'S SERIAL NUMBER AND TYPE.

24 (c) REGARDING THE PETITION, THE COURT SHALL RECORD:

- 25 (I) THE PETITION'S FILING DATE AND JURISDICTION;
- 26 (II) THE CATEGORY OF PETITIONER;
- 27 (III) THE ALLEGED THREAT, INCLUDING AGAINST THE RESPONDENT  
28 THEMSELF; ANOTHER PERSON; OR THREATS OF SUICIDE, THREATS OF  
29 MURDER, OR MENTAL HEALTH ISSUES LEADING TO THE THREAT OF  
30 IMMINENT HARM;

31 (IV) IF THERE ARE CHILDREN SHARED BETWEEN THE PETITIONER  
32 AND RESPONDENT OR IF EITHER THE PETITIONER OR RESPONDENT HAS  
33 CHILDREN OF THEIR OWN, AND THE AGE OF THE CHILDREN; AND

34 (V) THE SPECIFIC FILING TYPE.

35 (2) BEGINNING IN JANUARY 2027, AND IN JANUARY EVERY YEAR  
36 THEREAFTER, THE JUDICIAL DEPARTMENT SHALL INCLUDE, AS PART OF ITS  
37 PRESENTATION DURING ITS "SMART ACT" HEARING REQUIRED BY SECTION  
38 2-7-203, INFORMATION CONCERNING THE DATA DESCRIBED IN THIS  
39 SECTION."
