HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture, Water & Natural Resources.

HB26-1323 be amended as follows:

1 Amend printed bill, page 4, after line 7 insert:

2 "(d) "INFLATION" MEANS THE ANNUAL PERCENTAGE CHANGE IN  
3 THE UNITED STATES DEPARTMENT OF LABOR'S BUREAU OF LABOR  
4 STATISTICS CONSUMER PRICE INDEX, OR A SUCCESSOR INDEX, FOR  
5 DENVER-AURORA-LAKEWOOD FOR ALL ITEMS PAID FOR BY URBAN  
6 CONSUMERS."

7 Reletter succeeding paragraphs accordingly.

8 Page 4, after line 14 insert:

9 "(f) "RECREATIONAL PURPOSE" MEANS AN AVOCATIONAL TAKE BY  
10 RECREATIONAL SPORTSPEOPLE, AS OPPOSED TO A VOCATIONAL TAKE  
11 CONDUCTED BY WILDLIFE CONTROL OPERATORS, PRIVATE LANDOWNERS,  
12 AND OTHERS LETHALLY ADDRESSING CONFLICTS."

13 Reletter succeeding paragraph accordingly.

14 Page 5, line 11, strike "ONE THOUSAND DOLLARS;" and substitute "SEVEN  
15 HUNDRED DOLLARS, ANNUALLY ADJUSTED FOR INFLATION;"

16 Page 5, line 13, strike "TWENTY" and substitute "FIFTEEN".

17 Page 5, line 17, strike "OR".

18 Page 5, strike line 24 and substitute "AGREEMENT; OR

19 (c) PROHIBIT THE DIVISION FROM ISSUING LIMITED HARVEST  
20 LICENSES FOR BEAVERS ON SPECIFIED PUBLIC LANDS IF THE DIVISION  
21 DEMONSTRATES THAT THE HARVEST IS BIOLOGICALLY NECESSARY TO  
22 MINIMIZE CONFLICT WITH NATIVE, NONSTOCKED SPECIES OR TO PROTECT  
23 THE BIOLOGICAL INTEGRITY OF THE AREA. ANY HARVEST LICENSES ISSUED  
24 PURSUANT TO THIS SUBSECTION (6)(c) MUST BE LIMITED IN NUMBER,  
25 LOCATION, AND DURATION TO ADDRESS THE IDENTIFIED SITE-SPECIFIC  
26 CONDUCT. THE DIVISION SHALL PROVIDE NOTICE TO THE COMMISSION OF  
27 ANY HARVEST LICENSES ISSUED PURSUANT TO THIS SUBSECTION (6)(c) AT  
28 THE NEXT COMMISSION MEETING FOLLOWING THE ISSUANCE."
