SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

HB26-1198 be amended as follows:

1 Amend the reengrossed bill, page 3, line 23, strike "**animal shelters**".

2 Page 3, after line 26 insert:

3 "(a) (I) "COMPOUNDED" MEANS THE PREPARATION, MIXING,
4 ASSEMBLING, PACKAGING, OR LABELING OF A DRUG OR DEVICE:

5 (A) AS A RESULT OF A VETERINARIAN'S PRESCRIPTION DRUG
6 ORDER, CHART ORDER, OR INITIATIVE, BASED ON THE RELATIONSHIP
7 BETWEEN THE VETERINARIAN, PATIENT, AND PHARMACIST IN THE COURSE
8 OF PROFESSIONAL PRACTICE; OR

9 (B) FOR THE PURPOSE OF, OR AS AN INCIDENT TO, RESEARCH,
10 TEACHING, OR CHEMICAL ANALYSIS AND NOT FOR SALE OR DISPENSING.

11 (II) "COMPOUNDED" ALSO INCLUDES THE PREPARATION OF DRUGS
12 OR DEVICES IN ANTICIPATION OF PRESCRIPTION DRUG ORDERS BASED ON
13 ROUTINE, REGULARLY OBSERVED PRESCRIBING PATTERNS.

14 (b) "DRUG" HAS THE MEANING SET FORTH IN SECTION 12-280-103
15 (16).".

16 Reletter succeeding paragraphs accordingly.

17 Page 4, strike lines 6 through 11 and substitute "~~pursuant to subsection (1)~~
18 ~~of this section only~~ if

19 (1) the compounded drug is necessary for the treatment of ~~an~~
20 ~~animal~~ A patient's emergency condition. and

21 (2) ~~As determined by the veterinarian, the veterinarian cannot~~
22 ~~access, in a timely manner, the compounded drug through a registered~~
23 ~~prescription drug outlet.~~".

24 Page 4, strike lines 22 through 27.

25 Page 5, strike lines 1 through 13 and substitute:

26 "(4) A VETERINARIAN MAY COMPOUND AND DISPENSE
27 COMPOUNDED DRUGS FOR ANY PATIENT FOR WHICH THE VETERINARIAN
28 HAS A VETERINARIAN-CLIENT-PATIENT RELATIONSHIP AND THE
29 VETERINARIAN DETERMINES THAT IT IS DESIRABLE OR NECESSARY FOR THE
30 TREATMENT OF THE PATIENT'S CONDITION.".

31 Page 5, line 17, strike "12-280-120 (17) and".
