

SENATE FLOOR AMENDMENT

Second Reading

BY SENATORS Exum and Benavidez

1 Amend reengrossed bill, page 4, line 21, strike "**Statement of rights of**"
2 and substitute "**Required notice to**".

3 Page 4, strike line 26 and substitute:

4 "(I) A REQUIRED NOTICE TO BIRTHING PARENTS OF THE".

5 Page 5, strike lines 19 through 22 and substitute "BIRTHING PROCESS THAT
6 ALLEGES THE FOLLOWING:

7 (A) DISCRIMINATION BASED ON DISABILITY, RACE, CREED, COLOR,
8 SEX, SEXUAL ORIENTATION, GENDER IDENTITY, GENDER EXPRESSION,
9 MARITAL STATUS, NATIONAL ORIGIN, ANCESTRY, OR AGE;

10 (B) UNPROFESSIONAL CONDUCT OR NEGLIGENT MEDICAL CARE
11 FROM A LICENSED HEALTH-CARE PRACTITIONER, INCLUDING FAILURE TO
12 PROVIDE INFORMED CONSENT;

13 (C) UNSAFE CONDITIONS OR FAILURE TO ALLOW VISITATION
14 RIGHTS SPECIFIED IN SECTION 25-3-125, INCLUDING ALLOWING A BIRTHING
15 COMPANION OR DOULA IN ADDITION TO A PARTNER OR SPOUSE TO BE
16 PRESENT DURING LABOR AND BIRTH, AT A LICENSED HEALTH FACILITY; OR

17 (D) VIOLATION OF STATE OR FEDERAL PRIVACY AND SECURITY
18 LAWS, INCLUDING THE FEDERAL "HEALTH INSURANCE PORTABILITY AND
19 ACCOUNTABILITY ACT OF 1996", PUB.L. 104-191, AS AMENDED, AND ITS
20 IMPLEMENTING REGULATIONS."

21 Page 5, line 24, strike "(1.5)" and substitute "(1.5):".

22 Page 5, strike lines 25 and 26.

23 Page 6, line 6, before "HEALTH-CARE" insert "LICENSED".

24 Page 7, line 8, strike "BLACK".

25 Page 7, line 9, after "ADVOCATE" insert "REPRESENTING POPULATIONS
26 KNOWN TO HAVE THE WORST MATERNAL MORTALITY OUTCOMES IN
27 COLORADO".

28 Page 7, line 11, strike "MATERNAL" and substitute "POPULATIONS KNOWN
29 TO HAVE THE WORST MATERNAL MORTALITY OUTCOMES IN COLORADO
30 AND THE SUSPECTED OR KNOWN CAUSES OF THOSE OUTCOMES."

31 Page 7, strike lines 12 and 13.

1 Page 7, strike lines 22 through 24 and substitute:

2 "(VI) CERTAIN MATERNAL HEALTH OUTCOMES THAT ARE
3 IDENTIFIED FOR POPULATIONS KNOWN TO HAVE THE WORST MATERNAL
4 MORTALITY OUTCOMES IN COLORADO."
