HB26-1113 be amended as follows:

1 Amend reengrossed bill, page 7, after line 2 insert:

2 "SECTION 3. In Colorado Revised Statutes, 1-1-107, **add** (2)(e)
3 as follows:

4 **1-1-107. Powers and duties of secretary of state - penalty.**

5 (2) In addition to any other powers prescribed by law, the
6 secretary of state has the following powers:

7 (e) (I) To, IN CONSULTATION WITH THE GOVERNOR AND, AS
8 PRACTICABLE, THE ELECTION EMERGENCY ADVISORY GROUP ESTABLISHED
9 IN SUBSECTION (2)(e)(II) OF THIS SECTION, ADOPT RULES AS NECESSARY
10 FOR THE PROPER ADMINISTRATION OF AN ELECTION AND TO GIVE EFFECT
11 TO SECTION 1-1-103 (1), IF THE GOVERNOR DECLARES A DISASTER
12 EMERGENCY PURSUANT TO SECTION 24-33.5-704 (4) DUE TO THE
13 INABILITY TO STRICTLY COMPLY WITH THIS CODE, INCLUDING THE
14 SUSPENSION OF ANY LAW PURSUANT TO SECTION 24-33.5-704 (7)(a).

15 (II) IF THE GOVERNOR DECLARES A DISASTER EMERGENCY
16 PURSUANT TO SECTION 24-33.5-704 (4) DUE TO INABILITY TO STRICTLY
17 COMPLY WITH THIS CODE, THE GOVERNOR SHALL ESTABLISH THE ELECTION
18 EMERGENCY ADVISORY GROUP. THE SECRETARY OF STATE AND GOVERNOR
19 SHALL CONSULT AS PRACTICABLE WITH THE ELECTION EMERGENCY
20 ADVISORY GROUP ON EMERGENCY ORDERS OR RULES THAT THE
21 SECRETARY OF STATE MAY ADOPT AS MAY BE NECESSARY TO ENSURE THE
22 PROPER ADMINISTRATION OF AN ELECTION AND TO GIVE EFFECT TO
23 SECTION 1-1-103 (1).

24 (III) THE ELECTION EMERGENCY ADVISORY GROUP CONSISTS OF SIX
25 MEMBERS APPOINTED AS FOLLOWS:

26 (A) ONE REPRESENTATIVE FROM THE GOVERNOR'S OFFICE,
27 APPOINTED BY THE GOVERNOR;

28 (B) ONE REPRESENTATIVE FROM THE SECRETARY OF STATE'S
29 OFFICE, APPOINTED BY THE SECRETARY OF STATE;

30 (C) TWO CURRENT OR FORMER COUNTY CLERKS FROM DIFFERENT
31 MAJOR POLITICAL PARTIES, APPOINTED BY THE GOVERNOR IN
32 CONSULTATION WITH THE SECRETARY OF STATE; AND

33 (D) TWO INDIVIDUALS FROM DIFFERENT MAJOR POLITICAL PARTIES,
34 WITH EXPERTISE ON STATE OR FEDERAL ELECTION LAW, ADMINISTERING
35 ELECTIONS, VOTING, OR ANOTHER RELEVANT TOPIC, APPOINTED BY THE
36 GOVERNOR IN CONSULTATION WITH THE SECRETARY OF STATE.

37 (IV) THIS SUBSECTION (2)(e) IS REPEALED, EFFECTIVE JANUARY 31,
38 2031."
