1 Amend printed bill, page 4, line 8, strike "EMAIL." and substitute "EMAIL
2 IF THE LICENSEE, CERTIFICATE HOLDER, OR REGISTRANT CONFIRMS
3 RECEIPT OF THE EMAIL WITHIN SEVEN CALENDAR DAYS. IF THE LICENSEE,
4 CERTIFICATE HOLDER, OR REGISTRANT DOES NOT CONFIRM RECEIPT OF THE
5 EMAIL WITHIN SEVEN CALENDAR DAYS, THE REGULATOR SHALL SEND THE
6 LETTER OF ADMONITION THROUGH CERTIFIED OR FIRST-CLASS UNITED
7 STATES MAIL."

8 Page 4, line 26, strike "EMAIL." and substitute "EMAIL IF THE LICENSEE,
9 CERTIFICATE HOLDER, OR REGISTRANT CONFIRMS RECEIPT OF THE EMAIL
10 WITHIN SEVEN CALENDAR DAYS. IF THE LICENSEE, CERTIFICATE HOLDER,
11 OR REGISTRANT DOES NOT CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN
12 CALENDAR DAYS, THE REGULATOR SHALL SEND THE CONFIDENTIAL LETTER
13 OF CONCERN THROUGH CERTIFIED OR FIRST-CLASS UNITED STATES MAIL."

14 Page 5, line 10, after "EMAIL." add "FOR A DISCIPLINARY ACTION TAKEN
15 PURSUANT TO SECTION 12-20-404, THE REGULATOR MAY PROVIDE
16 COMMUNICATIONS THROUGH EMAIL IF THE LICENSEE, CERTIFICATE
17 HOLDER, OR REGISTRANT CONFIRMS RECEIPT OF THE EMAIL WITHIN SEVEN
18 CALENDAR DAYS. IF THE LICENSEE, CERTIFICATE HOLDER, OR REGISTRANT
19 DOES NOT CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN CALENDAR
20 DAYS, THE REGULATOR SHALL SEND THE COMMUNICATIONS THROUGH
21 CERTIFIED OR FIRST-CLASS UNITED STATES MAIL."

22 Page 5, line 20, strike "service, EMAIL, or proof" and substitute "service
23 or proof".

24 Page 5, line 23, after "document." add "IF THE REGULATOR SENDS THE
25 NOTICE THROUGH EMAIL, THE REGULATOR SHALL REQUEST THAT THE
26 PERSON CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN CALENDAR DAYS.
27 IF THE PERSON DOES NOT CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN
28 CALENDAR DAYS, THE REGULATOR SHALL SEND THE NOTICE THROUGH
29 PERSONAL SERVICE OR FIRST-CLASS UNITED STATES MAIL, POSTAGE
30 PREPAID."

31 Page 8, line 3, after "procedure." add "IF THE PROGRAM DIRECTOR OR THE
32 PROGRAM DIRECTOR'S DESIGNEE SENDS THE NOTICE THROUGH EMAIL, THE
33 PROGRAM DIRECTOR OR THE PROGRAM DIRECTOR'S DESIGNEE SHALL
34 REQUEST THAT THE PERSON CONFIRM RECEIPT OF THE EMAIL WITHIN
35 SEVEN CALENDAR DAYS. IF THE PERSON DOES NOT CONFIRM RECEIPT OF
36 THE EMAIL WITHIN SEVEN CALENDAR DAYS, THE PROGRAM DIRECTOR OR

1 THE PROGRAM DIRECTOR'S DESIGNEE SHALL SEND THE NOTICE THROUGH
2 CERTIFIED OR FIRST-CLASS UNITED STATES MAIL."

3 Page 9, line 3, after "section." add "If THE INQUIRY PANEL SENDS THE
4 NOTICE THROUGH EMAIL, THE INQUIRY PANEL SHALL REQUEST THAT THE
5 LICENSEE CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN CALENDAR DAYS.
6 IF THE LICENSEE DOES NOT CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN
7 CALENDAR DAYS, THE INQUIRY PANEL SHALL SEND THE NOTICE THROUGH
8 CERTIFIED OR FIRST-CLASS UNITED STATES MAIL."

9 Page 10, line 7, after "section." add "If THE BOARD SENDS THE NOTICE
10 THROUGH EMAIL, THE BOARD SHALL REQUEST THAT THE NURSE OR
11 CERTIFIED MIDWIFE CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN
12 CALENDAR DAYS. IF THE NURSE OR CERTIFIED MIDWIFE DOES NOT CONFIRM
13 RECEIPT OF THE EMAIL WITHIN SEVEN CALENDAR DAYS, THE BOARD SHALL
14 SEND THE NOTICE THROUGH CERTIFIED OR FIRST-CLASS UNITED STATES
15 MAIL."

16 Page 12, line 4, after "hearing." add "If THE BOARD SENDS THE NOTICE
17 THROUGH EMAIL, THE BOARD SHALL REQUEST THAT THE INSTITUTION
18 CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN CALENDAR DAYS. IF THE
19 INSTITUTION DOES NOT CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN
20 CALENDAR DAYS, THE BOARD SHALL SEND THE NOTICE THROUGH
21 CERTIFIED OR FIRST-CLASS UNITED STATES MAIL."

22 Page 12, line 11, after "licensee." add "If THE DIRECTOR SENDS THE
23 NOTICE THROUGH EMAIL, THE DIRECTOR SHALL REQUEST THAT THE
24 LICENSEE CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN CALENDAR DAYS.
25 IF THE LICENSEE DOES NOT CONFIRM RECEIPT OF THE EMAIL WITHIN SEVEN
26 CALENDAR DAYS, THE DIRECTOR SHALL SEND THE NOTICE THROUGH
27 CERTIFIED OR FIRST-CLASS UNITED STATES MAIL."
