HB26-1347 be amended as follows:

- 1 Amend printed bill, page 2, line 4, strike "(5)(a)," and substitute "(5)(a)
- 2 introductory portion, (5)(a)(III),".

- 3 Page 2, lines 5 and 6, strike "(8)(a.5), (8)(g.5), and (10) as follows:" and
- 4 substitute "(5)(a)(II.5), and (8)(a.5) as follows:".

- 5 Page 7, strike lines 15 through 27.

- 6 Page 8, strike lines 1 through 12.

- 7 Page 8, line 13, strike "(B)" and substitute "(II.5)".

- 8 Page 8, line 14, strike "THE COUNTY DEPARTMENT SHALL".

- 9 Page 8, line 18, after "SOURCE." insert "If THE COUNTY DEPARTMENT IS
- 10 THE REPRESENTATIVE PAYEE OR FIDUCIARY, THE COUNTY DEPARTMENT
- 11 MUST COMPLY WITH FEDERAL LAW AND RULES REGARDING MEETING WITH
- 12 THE CHILD OR YOUTH AND INTERESTED PARTIES TO DETERMINE THE
- 13 CHILD'S OR YOUTH'S REASONABLE AND FORESEEABLE NEEDS BEFORE
- 14 EXPENDING SUPPLEMENTAL SECURITY INCOME ON COST OF CARE.".

- 15 Page 8, lines 21 through 23, strike "INCOME, IF THE FEDERAL
- 16 SUPPLEMENTAL SECURITY INCOME IS DEPOSITED INTO AN ACCOUNT
- 17 PURSUANT TO SUBSECTION (5)(a)(II.5) OF THIS SECTION," and substitute
- 18 "INCOME".

- 19 Page 9, lines 1 and 2, strike "A COUNTY DEPARTMENT CHILD WELFARE
- 20 CASEWORKER" and substitute "COUNTY DEPARTMENT PERSONNEL".

- 21 Page 9, line 8, strike "and" and substitute "and, IF APPLICABLE, THE
- 22 AMOUNT".

- 23 Page 9, line 24, strike "OR FEDERAL SUPPLEMENTAL SECURITY INCOME".

- 24 Page 11, strike lines 11 through 15.

- 25 Page 12, strike lines 15 through 20.

- 26 Page 12, line 21, strike "(c)" and substitute "(b)".

- 27 Page 12, strike lines 26 and 27.

- 28 Page 13, strike lines 1 though 4.
