27 PRIMARILY TO SUPPORT SPECIFIC AND LIMITED INSTRUCTIONAL,
28 ADMINISTRATIVE, ACCESSIBILITY, OR STUDENT SUPPORT PURPOSES IN A
29 SCHOOL SETTING AND THAT IS NOT DESIGNED TO SIMULATE EMOTIONAL
30 COMPANIONSHIP OR ENCOURAGE EMOTIONALLY DEPENDENT
31 INTERACTION.".
