HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB26-1033 be amended as follows:

1 Amend the Agriculture, Water, and Natural Resources Committee Report,
2 dated February 26, 2026, page 3, after line 16 insert:

3 "Page 6 of the printed bill, after line 1 insert:

4 "SECTION 3. In Colorado Revised Statutes, **add** 25-4-1614.5 as
5 follows:

6 **25-4-1614.5. Cottage foods cash fund created.**

7 (1) THE COTTAGE FOODS CASH FUND IS CREATED IN THE STATE
8 TREASURY. THE COTTAGE FOODS CASH FUND CONSISTS OF MONEY
9 CREDITED TO THE COTTAGE FOODS CASH FUND PURSUANT TO SECTIONS
10 25-1.5-303 (5)(e) AND 25-27-107.5 (3) AND ANY OTHER MONEY THAT THE
11 GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER TO THE COTTAGE
12 FOODS CASH FUND.

13 (2) THE STATE TREASURER SHALL CREDIT ALL INTEREST AND
14 INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE
15 COTTAGE FOODS CASH FUND TO THE COTTAGE FOODS CASH FUND.

16 (3) MONEY IN THE COTTAGE FOODS CASH FUND IS CONTINUOUSLY
17 APPROPRIATED TO THE DEPARTMENT FOR ADMINISTRATION OF SECTION
18 25-4-1614.

19 **SECTION 4.** In Colorado Revised Statutes, 25-1.5-303, **add**
20 (5)(e) as follows:

21 **25-1.5-303. Medication reminder boxes or systems -**
22 **medication cash fund - repeal.**

23 (5)(e)(I) NOTWITHSTANDING SUBSECTION (5)(a) OF THIS SECTION,
24 ON JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER TWO HUNDRED
25 THOUSAND DOLLARS FROM THE MEDICATION ADMINISTRATION CASH FUND
26 CREATED IN SUBSECTION (5)(a) OF THIS SECTION TO THE COTTAGE FOODS
27 CASH FUND CREATED IN SECTION 25-4-1614.5.

28 (II) THIS SUBSECTION (5)(e) IS REPEALED, EFFECTIVE JULY 1, 2028.

29 **SECTION 5.** In Colorado Revised Statutes, 25-27-107.5, **add** (3)
30 as follows:

31 **25-27-107.5. Assisted living residence cash fund created -**
32 **repeal.**

33 (3) (a) NOTWITHSTANDING SUBSECTION (1) OF THIS SECTION, ON
34 JULY 1, 2026, THE STATE TREASURER SHALL TRANSFER ONE HUNDRED
35 THOUSAND DOLLARS FROM THE ASSISTED LIVING RESIDENCE CASH FUND
36 CREATED IN SUBSECTION (1) OF THIS SECTION TO THE COTTAGE FOODS
37 CASH FUND CREATED IN SECTION 25-4-1614.5.

38 (b) THIS SUBSECTION (3) IS REPEALED, EFFECTIVE JULY 1, 2028."

1 Renumber succeeding sections accordingly."

2 Page 3 of the report, strike lines 25 through 35 and substitute:

3 "Page 6 of the bill, strike lines 14 through 25 and substitute:

4 **"SECTION 7. Effective date.** This act takes effect upon passage;
5 except that section 25-4-1614, Colorado Revised Statutes, as amended in
6 section 2 of this act, and section 35-36-102, Colorado Revised Statutes,
7 as amended in section 6 of this act, take effect January 1, 2027.

8 **SECTION 8. Safety clause.** The general assembly finds,
9 determines, and declares that this act is necessary for the immediate
10 preservation of the public peace, health, or safety or for appropriations for
11 the support and maintenance of the departments of the state and state
12 institutions."."
