1 Amend the Finance Committee Report, dated April 23, 2026, page 2, line
2 26, after ""REQUIRED TIME FRAME." insert "IF A HEALTH-CARE FACILITY
3 IS UNABLE TO COMPLY WITH A REQUEST FOR MEDICAL RECORDS WITHIN
4 THE TIME REQUIRED PURSUANT TO THIS SUBSECTION (1)(f)(IV) DUE TO A
5 FORCE MAJEURE EVENT, THE FACILITY SHALL PROVIDE WRITTEN NOTICE TO
6 THE REQUESTOR. THE NOTICE MUST BE GIVEN AS SOON AS REASONABLY
7 PRACTICABLE, BUT NOT LATER THAN FIVE BUSINESS DAYS AFTER THE
8 FACILITY BECOMES AWARE OF THE FORCE MAJEURE EVENT. FOR EXISTING
9 REQUESTS, OR NOT LATER THAN FIVE BUSINESS DAYS AFTER RECEIPT OF A
10 NEW REQUEST, THE THIRTY DAY TIME PERIOD TO RESPOND TO A REQUEST
11 FOR RECORDS COMMENCES UPON RESOLUTION OF THE FORCE MAJEURE
12 EVENT. THE ENTITY SHALL NOTIFY THE REQUESTOR WITHIN FIVE BUSINESS
13 DAYS AFTER THE FORCE MAJEURE EVENT HAS BEEN RESOLVED. ALL
14 NOTICES REQUIRED PURSUANT TO THIS SUBSECTION (1)(f)(IV) must BE
15 DELIVERED IN THE SAME FORMAT IN WHICH IT WAS RECEIVED."

16 Page 4, line 7, after ""REQUIRED TIME FRAME." insert "IF A HEALTH-CARE
17 FACILITY IS UNABLE TO COMPLY WITH A REQUEST FOR MEDICAL RECORDS
18 WITHIN THE TIME REQUIRED PURSUANT TO THIS SUBSECTION (1)(f)(IV)
19 DUE TO A FORCE MAJEURE EVENT, THE FACILITY SHALL PROVIDE WRITTEN
20 NOTICE TO THE REQUESTOR. THE NOTICE MUST BE GIVEN AS SOON AS
21 REASONABLY PRACTICABLE, BUT NOT LATER THAN FIVE BUSINESS DAYS
22 AFTER THE FACILITY BECOMES AWARE OF THE FORCE MAJEURE EVENT.
23 FOR EXISTING REQUESTS, OR NOT LATER THAN FIVE BUSINESS DAYS AFTER
24 RECEIPT OF A NEW REQUEST, THE THIRTY DAY TIME PERIOD TO RESPOND TO
25 A REQUEST FOR RECORDS COMMENCES UPON RESOLUTION OF THE FORCE
26 MAJEURE EVENT. THE ENTITY SHALL NOTIFY THE REQUESTOR WITHIN FIVE
27 BUSINESS DAYS AFTER THE FORCE MAJEURE EVENT HAS BEEN RESOLVED.
28 ALL NOTICES REQUIRED PURSUANT TO THIS SUBSECTION (1)(f)(IV) MUST
29 BE DELIVERED IN THE SAME FORMAT IN WHICH IT WAS RECEIVED."
