Committee on Judiciary.

HB26-1421 be amended as follows:

1 Amend printed bill, page 7, strike lines 3 through 12 and substitute:

2 "(6) "LEGAL SERVICES" MEANS ANY OF THE FOLLOWING WHILE
3 ACTING IN A REPRESENTATIVE CAPACITY CONCERNING A LEGAL RIGHT
4 ARISING IN WHOLE OR IN PART IN COLORADO:

5 (a) PROTECTING, DEFENDING, OR ENFORCING THE LEGAL RIGHTS OR
6 DUTIES OF ANOTHER PERSON;

7 (b) REPRESENTING ANOTHER PERSON BEFORE A TRIBUNAL OR, ON
8 BEHALF OF ANOTHER PERSON, DRAFTING PLEADINGS OR OTHER PAPERS FOR
9 A PROCEEDING BEFORE A TRIBUNAL;

10 (c) COUNSELING, ADVISING, OR ASSISTING ANOTHER PERSON IN
11 CONNECTION WITH THAT PERSON'S LEGAL RIGHTS OR DUTIES;

12 (d) EXERCISING LEGAL JUDGMENT IN PREPARING LEGAL
13 DOCUMENTS FOR ANOTHER PERSON;

14 (e) EXERCISING LEGAL JUDGMENT TO ADVISE ANOTHER PERSON
15 ABOUT THE LEGAL EFFECT OF A PROPOSED ACTION OR DECISION;

16 (f) EXERCISING LEGAL JUDGMENT TO ADVISE ANOTHER PERSON
17 ABOUT LEGAL REMEDIES OR POSSIBLE COURSES OF LEGAL ACTION
18 AVAILABLE TO THAT PERSON;

19 (g) EXERCISING LEGAL JUDGMENT TO SELECT A LEGAL DOCUMENT
20 FOR ANOTHER PERSON OR TO PREPARE A LEGAL DOCUMENT FOR ANOTHER
21 PERSON OTHER THAN SOLELY AS A TYPIST OR SCRIVENER;

22 (h) EXERCISING LEGAL JUDGMENT TO REPRESENT OR ADVOCATE
23 FOR ANOTHER PERSON IN A NEGOTIATION, SETTLEMENT, CONFERENCE,
24 MEDIATION, OR ALTERNATIVE DISPUTE RESOLUTION PROCEEDING; AND

25 (i) SOLICITING FEES FOR SERVICES INVOLVING THE EXERCISE OF
26 LEGAL JUDGMENT."

27 Page 7, lines 21 and 22, strike "AND IS NOT AN LLP." and substitute "OR
28 IS NOT AUTHORIZED TO PRACTICE LAW BY THE COLORADO SUPREME
29 COURT."
