5 CREATED IN SECTION 25.5-6-1404.".
- 6 Page 3 of the Appropriations report, line 12, strike "bill line 8," and
7 substitute "bill, lines 8 and 9,".
- 8 Page 3 of the Appropriations report, strike line 23 and insert
9 "INSURANCE.".
- 10 Page 14 of the bill, line 16, strike "IS AUTHORIZED TO:" and substitute
11 "HAS THE POWER AND DUTY TO:".
- 12 Page 3 of the Appropriations report, after line 23 insert:
13 "Page 1 of the HHS report, line 16, strike "AND"."
- 14 Page 4 of the Appropriations report, line 11, strike "25.5-1-1207." and
15 substitute "25.5-1-1207; AND
16 (e) NO LATER THAN SEPTEMBER 1, 2028, AND NO LATER THAN
17 SEPTEMBER 1, EACH YEAR THEREAFTER, THE BOARD SHALL DETERMINE
18 THE PERCENTAGE ALLOCATION OF FEE REVENUE FOR THE USES OF
19 ENTERPRISE REVENUE SPECIFIED IN SUBSECTIONS (5)(d)(III) AND
20 (5)(d)(IV) OF THIS SECTION.".
- 21 Page 5 of the Appropriations report, after line 8 insert:
22 "Page 3 of the HHS report, line 25, strike "AND DUE DATES"."
- 23 Page 5 of the Appropriations report, strike line 11 and substitute
24 "SECTION. EXCEPT AS PROVIDED IN SUBSECTION (2)(c)(I) OF THIS SECTION,
25 A LARGE EMPLOYER SHALL PAY THE LARGE EMPLOYER HEALTH-CARE
26 SUPPORT FEE BY AUGUST 1, 2028, AND NO LATER THAN AUGUST 1
27 THEREAFTER IN THE CALENDAR YEAR IN WHICH THE FEE IS IMPOSED
28 PURSUANT TO SUBSECTION (2)(c)(II) OF THIS SECTION.".
- 29 Page 5 of the Appropriations report, strike line 19 and substitute:
30 "Page 5 of the HHS report, strike lines 19 through 29.
31 Reletter succeeding paragraphs accordingly."
