

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

HB25-1146 be amended as follows:

1 Amend proposed committee amendment (HB1146\_L.005), page 2, line  
2 29, strike "AND".

3 Page 2, strike line 34 and substitute:

4 "FACILITY; AND

5 (V) SERVICES THAT WOULD MITIGATE THE SUBSTANTIAL RISK OF  
6 HARM TO OTHERS THAT ARE PRESENTED BY THE JUVENILE OR THE  
7 JUVENILE'S RISK OF FLIGHT FROM PROSECUTION ARE UNAVAILABLE FOR A  
8 JUVENILE CURRENTLY PLACED IN DETENTION IN THE JUDICIAL DISTRICT AS  
9 DEMONSTRATED IN THE REPORT PURSUANT TO SUBSECTION (4)(c)(IV) OF  
10 THIS SECTION.".

11 Page 4, strike lines 20 through 24 and substitute:

12 "~~order~~ BEGINNING AUGUST 15, 2025, THE DEPARTMENT SHALL REPORT  
13 ON A MONTHLY BASIS AN AGGREGATED REPORT OF THE STATUS OF ALL  
14 YOUTH WHO ARE IN DETENTION AND WHO ARE AWAITING SERVICES THAT  
15 WOULD MITIGATE THE SUBSTANTIAL RISK OF HARM TO OTHERS THAT ARE  
16 PRESENTED BY THE JUVENILE OR THE JUVENILE'S RISK OF FLIGHT FROM  
17 PROSECUTION AND THE NUMBER OF EMERGENCY BEDS USED BY EACH  
18 JUDICIAL DISTRICT OR FACILITY.".

19 Page 5, strike lines 23 through 26 and substitute:

20 "THE PILOT PROGRAM IS ESTABLISHED, THE DIVISION OF YOUTH SERVICES  
21 SHALL ESTABLISH POLICIES AND PROCEDURES CONCERNING BODY-WORN  
22 CAMERAS, WHICH ARE SUBJECT TO REVIEW BY THE DIVISION OF YOUTH  
23 SERVICES' POLICY REVIEW COMMITTEE. THE POLICIES AND PROCEDURES  
24 MUST ADDRESS, AT A MINIMUM:

25 (a) WHEN BODY-WORN CAMERAS MUST BE ACTIVATED;

26 (b) THE RETENTION OF BODY-WORN CAMERA FOOTAGE; AND

27 (c) ACCESS TO BODY-WORN CAMERA FOOTAGE, WHICH MUST  
28 ENSURE APPROPRIATE PROTECTIONS OF YOUTH PRIVACY, INCLUDING  
29 COMPLIANCE WITH LAWS AND REGULATIONS AND ADDRESSES ACCESS BY  
30 THE OFFICE OF THE CHILD PROTECTION OMBUDSMAN, YOUTH, AND YOUTH'S  
31 COUNSEL WHO HAVE ALLEGED ABUSE.".
