5 substitute "APPLICATION;".

6 Page 4 of the bill, strike line 23 and substitute "WITH, A SOCIAL MEDIA
7 PLATFORM; OR

8 (C) IS A WEBSITE, ONLINE SERVICE, ONLINE APPLICATION, OR
9 MOBILE APPLICATION WHOSE PRIMARY PURPOSE IS PROVIDING HEALTH
10 INFORMATION, HEALTH EDUCATION, OR HEALTH NAVIGATION SERVICES;
11 FACILITATING ACCESS TO REPRODUCTIVE HEALTH CARE, SEXUAL HEALTH
12 SERVICES, OR RELATED PATIENT ADVOCACY OR SUPPORT SERVICES; OR
13 CONNECTING INDIVIDUALS WITH PROVIDERS OF LEGALLY PROTECTED
14 HEALTH-CARE ACTIVITY, AS DEFINED IN SECTION 12-30-121 (1)(d), SO
15 LONG AS THE SERVICE OR APPLICATION IS NOT A FEATURE OR SERVICE OF,
16 OR OTHERWISE ASSOCIATED OR AFFILIATED WITH, A SOCIAL MEDIA
17 PLATFORM THAT DOES NOT PRIMARILY PROVIDE SUCH HEALTH-CARE
18 SERVICES."."

19 Page 2 of the report, after line 19 insert:
20 "Page 7 of the bill, strike line 18 and substitute "SECTION 16-3-313
21 (1)(b)."."

22 Page 2 of report, after line 26 insert:
23 "Page 8 of the bill, strike line 20 and substitute "**added by Senate Bill**
24 **26-011** (1)(a)(III), (4) introductory portion, and (7)(e) as".

25 Page 8 of the bill, after line 23 insert:
26 "(1) As used in this section, unless the context otherwise requires:
27 (a) (III) "Covered platform" does not include a service or
28 application that:

29 (A) Is used to facilitate communication within a business or
30 enterprise among employees or affiliates of the business or enterprise, so
31 long as access to the service or application is restricted to employees or
32 affiliates of the business or enterprise using the service or application; ~~or~~

33 (B) Has the exclusive purposes of offering the commercial sale of
34 goods and facilitating commercial transactions between buyers and
35 sellers, so long as the service or application is not a feature or service of,
36 or otherwise associated or affiliated with, a covered platform; OR

7 HEALTH-CARE ACTIVITY, AS DEFINED IN SECTION 12-30-121 (1)(d), SO
8 LONG AS THE SERVICE OR APPLICATION IS NOT A FEATURE OR SERVICE OF,
9 OR OTHERWISE ASSOCIATED OR AFFILIATED WITH, A SOCIAL MEDIA
10 PLATFORM THAT DOES NOT PRIMARILY PROVIDE SUCH HEALTH-CARE
11 SERVICES."."
