

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

SB26-080 be amended as follows:

1 Amend reengrossed bill, page 17, after line 27 insert:

2           "(6) (a) IF, ON OR BEFORE DECEMBER 31, 2028, THE MONEY IN THE  
3 FUND HAS NEVER REACHED OR EXCEEDED NINE HUNDRED THOUSAND  
4 DOLLARS, THE STATE TREASURER SHALL RETURN FROM THE FUND TO THE  
5 GRANTOR OR DONOR THE AMOUNT OF THE GRANTOR'S OR DONOR'S GIFTS,  
6 GRANTS, OR DONATIONS AND, NOTWITHSTANDING SUBSECTION (2) OF THIS  
7 SECTION, THE STATE DEPARTMENT SHALL NOT ACCEPT ADDITIONAL GIFTS,  
8 GRANTS, OR DONATIONS FOR THE PURPOSES OF THIS ARTICLE 25.

9           (b) IF ANY MONEY REMAINS IN THE FUND AFTER THE STATE  
10 TREASURER RETURNS MONEY TO DONORS OR GRANTORS PURSUANT TO  
11 SUBSECTION (6)(a) OF THIS SECTION, AS APPLICABLE, THE STATE  
12 TREASURER SHALL, PRIOR TO THE REPEAL OF THE FUND, TRANSFER ALL  
13 UNEXPENDED AND UNENCUMBERED MONEY IN THE FUND TO THE GENERAL  
14 FUND."

15 Page 18, line 5, strike "RECEIVES" and substitute "RECEIVES, ON OR  
16 BEFORE DECEMBER 31, 2028,".

17 Page 18, strike lines 16 through 18 and substitute:

18           "(2) THIS ARTICLE 25 AND SECTION 24-34-104 (34)(a)(XIV) ARE  
19 REPEALED, EFFECTIVE JANUARY 31, 2029; EXCEPT THAT, IF THE CONDITION  
20 SPECIFIED IN SUBSECTION (1) OF THIS SECTION OCCURS:

21           (a) SECTION 24-34-104 (34)(a)(XIV) IS NOT REPEALED PURSUANT  
22 TO THIS SUBSECTION (2);

23           (b) THIS ARTICLE 25 IS REPEALED, EFFECTIVE SEPTEMBER 1, 2033;  
24 AND

25           (c) BEFORE THE REPEAL OCCURS PURSUANT TO SUBSECTION (2)(b)  
26 OF THIS SECTION, THIS ARTICLE 25 IS SCHEDULED FOR REVIEW IN  
27 ACCORDANCE WITH SECTION 24-34-104."
