SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

SB25-007 be amended as follows:

1 Amend printed bill, page 5, strike lines 11 and 12 and substitute:

2 "(4) IN ADMINISTERING AND IMPLEMENTING THIS SECTION, THE  
3 DIRECTOR:

4 (a) SHALL COLLABORATE WITH CULTURAL FIRE PRACTITIONERS,  
5 CERTIFIED PRESCRIBED BURN MANAGERS, THE COLORADO PRESCRIBED  
6 FIRE COUNCIL, AND OTHER RELEVANT STATE AGENCIES AND FIRE  
7 PRACTITIONERS;

8 (b) MAY ADOPT RULES AND GUIDELINES FOR THE ADMINISTRATION  
9 AND IMPLEMENTATION OF THIS SECTION; AND

10 (c) SHALL POST ANY RULES OR GUIDELINES ADOPTED PURSUANT TO  
11 SUBSECTION (4)(b) OF THIS SECTION ON THE DIVISION'S PUBLICLY  
12 ACCESSIBLE WEBSITE."

13 Page 5, line 16, strike "BURN." and substitute "BURN AGAINST THE  
14 CERTIFIED PRESCRIBED BURN MANAGER THAT CONDUCTED THE BURN; ANY  
15 ORGANIZATION, ENTITY, OR INDIVIDUAL WITH WHOM THE CERTIFIED  
16 PRESCRIBED BURN MANAGER WORKED TO CONDUCT THE BURN; ANY  
17 INDIVIDUAL OR ENTITY THAT PROVIDED FUNDING FOR THE BURN; AND ANY  
18 LANDOWNER ON WHOSE BEHALF THE BURN WAS CONDUCTED. NOTHING IN  
19 THIS SECTION PREVENTS A CLAIMANT FROM:

20 (a) SUBMITTING AN INSURANCE CLAIM RELATED TO COSTS OR  
21 DAMAGES THAT RESULTED FROM A BURN THAT WAS NOT CERTIFIED  
22 PURSUANT TO SUBSECTION (3) OF THIS SECTION; OR

23 (b) BRINGING A CLAIM RELATED TO COSTS OR DAMAGES AGAINST  
24 A PARTY THAT IS NOT LISTED IN THIS SUBSECTION (5), AS LONG AS THE  
25 CLAIM DOES NOT RESULT IN RECOVERY OF COSTS AND DAMAGES THAT ARE  
26 RECOVERED PURSUANT TO THIS SECTION."
