Representative Caldwell moved to amend the Report of the Committee of the Whole to reverse the action taken by the Committee in not adopting the following Armagost amendment, (L.058) to SB25-276, to show that said amendment passed and that SB25-276, as amended, passed.

Amend reengrossed bill, page 20, before line 26 insert:

"24-74.1-104. Loss of federal funding - notice to the revisor of statutes. THIS ARTICLE 74.1, SECTION 23-7-110 (2) AND (4), SECTION 42-2-505, SECTION 16-4-102 (2)(e.5), SECTION 18-1-410.6, ARTICLE 74 OF THIS TITLE 24, ARTICLE 76.6 OF THIS TITLE 24, ARTICLE 76.7 OF THIS TITLE 24, SECTION 28-3-103, SECTION 6-1-1303 (17.4), SECTION 6-1-1308 (7), SECTION 8-3.8-101 (2), SECTION 13-1-402 (6), SECTION 13-1-403, SECTION 22-2-117 (1)(b)(XI), SECTION 22-30.5-104 (6)(c)(XII), AND SECTION 22-30.5-507 (7)(b)(XII) WILL BE REPEALED IF ANY PROVISION OF SENATE BILL 25-276, ENACTED IN 2025, RESULTS IN THE STATE, INCLUDING ANY DEPARTMENT THEREOF, NOT RECEIVING ANY AMOUNT OF FEDERAL FUNDING TO WHICH IT IS OTHERWISE ENTITLED BECAUSE A PROVISION OF SENATE BILL 25-276 CAUSED THE STATE TO BE OUT OF COMPLIANCE WITH FEDERAL LAW OR REGULATION. THE DIRECTOR OF RESEARCH OF THE LEGISLATIVE COUNCIL OF THE GENERAL ASSEMBLY SHALL NOTIFY THE REVISOR OF STATUTES IN WRITING IF THE DIRECTOR DETERMINES THAT THE STATE HAS NOT RECEIVED ANY AMOUNT OF FEDERAL FUNDING TO WHICH IT IS OTHERWISE ENTITLED BECAUSE A PROVISION OF SENATE BILL 25-276 CAUSED THE STATE TO BE OUT OF COMPLIANCE WITH FEDERAL LAW OR REGULATION BY EMAILING THE NOTICE TO REVISOROFSTATUTES.GA@COLEG.GOV. THIS ARTICLE 74.1, SECTION 23-7-110 (2) AND (4), SECTION 42-2-505, SECTION 16-4-102 (2)(e.5), SECTION 18-1-410.6, ARTICLE 74 OF THIS TITLE 24, ARTICLE 76.6 OF THIS TITLE 24, ARTICLE 76.7 OF THIS TITLE 24, SECTION 28-3-103, SECTION 6-1-1303 (17.4), SECTION 6-1-1308 (7), SECTION 8-3.8-101 (2), SECTION 13-1-402 (6), SECTION 13-1-403, SECTION 22-2-117 (1)(b)(XI), SECTION 22-30.5-104 (6)(c)(XII), AND SECTION 22-30.5-507 (7)(b)(XII) ARE REPEALED, EFFECTIVE UPON THE DATE IDENTIFIED IN THE NOTICE THAT THE STATE HAS NOT RECEIVED FEDERAL FUNDING OR, IF THE NOTICE DOES NOT SPECIFY THAT DATE, UPON THE DATE OF THE NOTICE TO THE REVISOR OF STATUTES.".
