

## SENATE FLOOR AMENDMENT

Third Reading

1 Amend engrossed bill, page 18, strike lines 24 through 27 and substitute:

2        "(I) PROCEDURES TO PROVIDE, AS SPECIFICALLY REQUIRED BY  
3 STATE AND FEDERAL LAW, ANY PERSONAL IDENTIFYING INFORMATION  
4 ABOUT A CHILD OR STUDENT WHO WAS OR IS ENROLLED IN THE PUBLIC  
5 CHILD CARE CENTER, PUBLIC SCHOOL, LOCAL EDUCATION PROVIDER, OR  
6 PUBLIC INSTITUTION OF HIGHER EDUCATION; A PATIENT WHO SOUGHT,  
7 RECEIVED, IS SEEKING, OR IS RECEIVING SERVICES FROM THE PUBLIC  
8 HEALTH-CARE FACILITY; OR A PATRON WHO ACCESSED OR IS ACCESSING  
9 SERVICES, OR WAS OR IS PRESENT, AT A PUBLICLY SUPPORTED LIBRARY;

10        (II) PROCEDURES TO PROVIDE, AS SPECIFICALLY REQUIRED BY  
11 STATE AND FEDERAL LAW, ANY INFORMATION ABOUT A PARENT,  
12 GUARDIAN, OR RELATIVE OF A CHILD, STUDENT, PATIENT, OR PATRON;

13        (III) PROCEDURES TO PROVIDE ACCESS, OR CONSENT TO ACCESS,  
14 AS SPECIFICALLY REQUIRED BY STATE AND FEDERAL LAW, A PART OF THE  
15 PUBLIC CHILD CARE CENTER'S, PUBLIC SCHOOL'S, LOCAL EDUCATION  
16 PROVIDER'S, PUBLIC INSTITUTION OF HIGHER EDUCATION'S, PUBLIC  
17 HEALTH-CARE FACILITY'S, OR PUBLICLY SUPPORTED LIBRARY'S FACILITY,  
18 AUXILIARY FACILITY, PROPERTY, GROUNDS, OR SURROUNDING AREA THAT  
19 IS NOT ACCESSIBLE TO THE PUBLIC;

20        (IV) PROCEDURES TO PROPERLY RELEASE INFORMATION  
21 SPECIFICALLY REQUIRED BY STATE AND FEDERAL LAW THAT IS OTHERWISE  
22 PROTECTED IF".

23        Renumber succeeding subparagraphs accordingly.

24        Page 20, line 6, strike "1973." and substitute "1373.".

25        Page 20, line 13, strike "(1) OR (2)" and substitute "(1), (2), OR (3)(a)".

26        Page 21, strike line 27 and substitute "THEIR IMMIGRATION STATUS.".

27        Page 22, strike lines 1 through 3.
