1 Amend printed bill, page 24, after line 20 insert:

2 **"SECTION 22.** In Colorado Revised Statutes, 13-1-402, **add (6)**
3 as follows:

4 **13-1-402. Definitions.** As used in this part 4, unless the context
5 otherwise requires:

6 **(6) "RELATED FACILITY"** MEANS THE FOLLOWING FACILITIES,
7 FACILITIES WHERE THE FOLLOWING PROGRAMS OR SERVICES ARE
8 PROVIDED, OR FACILITIES WHERE THE FOLLOWING PROVIDERS PROVIDE
9 PROGRAMS OR SERVICES IN RELATION TO A COURT PROCEEDING,
10 INCLUDING:

11 (a) A BEHAVIORAL HEALTH ENTITY, AS DEFINED IN SECTION
12 27-50-101;

13 (b) A BEHAVIORAL HEALTH PROGRAM, AS DEFINED IN SECTION
14 27-50-101;

15 (c) A BEHAVIORAL HEALTH PROVIDER, AS DEFINED IN SECTION
16 27-50-101;

17 (d) A BEHAVIORAL HEALTH SAFETY NET PROVIDER, AS DEFINED IN
18 SECTION 27-50-101;

19 (e) A BEHAVIORAL HEALTH SAFETY NET SERVICE, AS DEFINED IN
20 SECTION 27-50-101;

21 (f) A COMPREHENSIVE COMMUNITY BEHAVIORAL HEALTH
22 PROVIDER, AS DEFINED IN SECTION 27-50-101;

23 (g) AN ESSENTIAL BEHAVIORAL HEALTH SAFETY NET PROVIDER, AS
24 DEFINED IN SECTION 27-50-101;

25 (h) A HOSPITAL THAT IS OPERATED BY THE DEPARTMENT OF
26 HUMAN SERVICES;

27 (i) A PSYCHIATRIC HOSPITAL THAT IS OPERATED BY THE
28 DEPARTMENT OF HUMAN SERVICES;

29 (j) A DETENTION OR COMMITMENT FACILITY THAT IS OPERATED BY
30 THE DEPARTMENT OF HUMAN SERVICES; OR

31 (k) A NURSING HOME.

32 **SECTION 23.** In Colorado Revised Statutes, 13-1-403, **amend**
33 (1) as follows:

34 **13-1-403. Prohibition of civil arrest - writ of protection -**
35 **procedure.** (1) A person ~~shall not be~~ IS NOT subject to civil arrest while
36 the person is present at a courthouse or on its environs; or while going to,
37 attending, or coming from a court proceeding; OR WHILE THE PERSON IS
38 RECEIVING TREATMENT IN A RELATED FACILITY.".
