SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB25-276 be amended as follows:

1 Amend printed bill, page 5, line 15, strike "THIS SENATE BILL 25-__" and
2 substitute "SENATE BILL 25-276".

3 Page 9, line 10, strike "AUTHORITY,".

4 Page 11, strike lines 1 through 3 and substitute "a person's immigration
5 status for the purpose of identifying if the person has complied with
6 federal immigration laws, including civil immigration laws and 8 U.S.C.
7 sec. 1325 or 1326, except as required by state or federal".

8 Page 11, line 14, strike "housing" and substitute "HEALTH CARE,
9 housing,".

10 Page 13, line 24, strike "**civil penalty.**" and substitute "**civil penalty -**
11 **legislative declaration.**".

12 Page 14, after line 6 insert:

13 "(3) FOR PURPOSES OF AN ACTION FOR A TEMPORARY RESTRAINING
14 ORDER OR PRELIMINARY INJUNCTION BROUGHT PURSUANT TO THIS
15 SECTION, THE GENERAL ASSEMBLY FINDS AND DECLARES THAT VIOLATION
16 OF THIS ARTICLE 74 POSES A REAL, IMMEDIATE, AND IRREPARABLE INJURY
17 FOR WHICH THERE IS NO PLAIN, SPEEDY, AND ADEQUATE REMEDY AT LAW,
18 AND THE PUBLIC INTEREST IS SERVED BY COMPLIANCE WITH THIS ARTICLE
19 74.".

20 Page 19, after line 25 insert:

21 "(3) FOR PURPOSES OF AN ACTION FOR A TEMPORARY RESTRAINING
22 ORDER OR PRELIMINARY INJUNCTION BROUGHT PURSUANT TO THIS
23 SECTION, THE GENERAL ASSEMBLY FINDS AND DECLARES THAT VIOLATION
24 OF THIS ARTICLE 74.1 POSES A REAL, IMMEDIATE, AND IRREPARABLE
25 INJURY FOR WHICH THERE IS NO PLAIN, SPEEDY, AND ADEQUATE REMEDY
26 AT LAW, AND THE PUBLIC INTEREST IS SERVED BY COMPLIANCE WITH THIS
27 ARTICLE 74.1.".

28 Page 22, line 13, after "(1)" insert "(a)".

29 Page 22, after line 16 insert:

30 "(b) FOR PURPOSES OF THIS SUBSECTION (1), "PRETRIAL OFFICER"
31 OR "PRETRIAL SERVICES OFFICE EMPLOYEE" INCLUDES AN AGENT OF A
32 PRETRIAL SERVICES OFFICE WHEN ACTING ON BEHALF OF, OR AT THE
33 DIRECTION OF, A PRETRIAL SERVICES OFFICE IN THEIR CAPACITY AS AN
34 AGENT OF A PRETRIAL SERVICES OFFICE.".
