Committee on Transportation, Housing & Local Government.

SB25-187 be amended as follows:

1 Amend reengrossed bill, page 3, after line 21 insert:

2 "SECTION 6. In Colorado Revised Statutes, 43-5-504, **add** (4)  
3 as follows:

4 **43-5-504. Motorcycle operator safety training fund - tuition**  
5 **benefit - definitions.** (4) (a) NOTWITHSTANDING ANY PROVISION OF THIS  
6 SECTION TO THE CONTRARY, THE CHIEF MAY EXPEND MONEY FROM THE  
7 FUND FOR A TUITION BENEFIT PAID TO **MOST** VENDORS TO BE PASSED ON  
8 TO ELIGIBLE STUDENTS IN THE FORM OF REDUCED COSTS FOR ELIGIBLE  
9 COURSES AS PROVIDED IN THIS SUBSECTION (4).

10 (b) TO BE ELIGIBLE TO RECEIVE A TUITION BENEFIT TO PASS ON TO  
11 ELIGIBLE STUDENTS, A **MOST** VENDOR SHALL PROVIDE A RECEIPT  
12 ESTABLISHING THAT THE TUITION BENEFIT WAS PASSED ON TO AN ELIGIBLE  
13 STUDENT WHO FULLY COMPLETED THE TRAINING AND ANY OTHER  
14 DOCUMENTATION REQUIRED BY THE CHIEF AS ESTABLISHED BY RULE.

15 (c) THE CHIEF SHALL DETERMINE THE ALLOCATION FOR A **MOST**  
16 VENDOR FOR THE TUITION BENEFIT ALLOWED IN THIS SUBSECTION (4)  
17 BASED ON THE FOLLOWING FACTORS, OR AS OTHERWISE PROVIDED BY  
18 RULE:

19 (I) THE AMOUNT OF MONEY IN THE FUND;

20 (II) FOR A **MOST** VENDOR THAT HAS BEEN CERTIFIED FOR OVER  
21 TWO YEARS, THE HISTORICAL DATA FOR ELIGIBLE STUDENTS AND ELIGIBLE  
22 COURSES OVER THE PREVIOUS TWO YEARS; OR

23 (III) FOR A **MOST** VENDOR THAT HAS BEEN CERTIFIED FOR TWO  
24 YEARS OR LESS, THE AVAILABLE HISTORICAL DATA FOR ELIGIBLE  
25 STUDENTS AND ELIGIBLE COURSES OR AN ESTIMATE OF THE ELIGIBLE  
26 STUDENTS AND ELIGIBLE COURSES.

27 (d) AS USED IN THIS SUBSECTION (4), UNLESS THE CONTEXT  
28 OTHERWISE REQUIRES:

29 (I) "ELIGIBLE COURSE" MEANS A CERTIFIED MOTORCYCLE  
30 OPERATOR SAFETY TRAINING COURSE THAT MEETS ALL REQUIREMENTS  
31 ESTABLISHED BY RULE.

32 (II) "ELIGIBLE STUDENT" MEANS AN INDIVIDUAL WHO IS ELIGIBLE  
33 TO ENROLL IN AN ELIGIBLE COURSE AND WHO MEETS ALL OTHER  
34 REQUIREMENTS ESTABLISHED BY RULE.

35 (e) THE CHIEF MAY ADOPT RULES AS NECESSARY FOR THE  
36 IMPLEMENTATION OF THIS SUBSECTION (4)."

37 Renumber succeeding section accordingly.
