- 1 Amend the Business Affairs and Labor Committee Report, dated April 3,  
2 2025, page 4, line 1, strike "- **state agencies**".
- 3 Page 4, lines 2 and 3, strike "RULE, ORDINANCE, OR REGULATION" and  
4 substitute "ORDINANCE OR RESOLUTION, IN ACCORDANCE WITH 34 U.S.C.  
5 SEC. 41101,".
- 6 Page 6, line 19, strike "(2)(a.5), (3.5), and (4)(c.5)" and substitute  
7 "(2)(a.5) and (3.5); and **repeal** (4)(c.5)".
- 8 Page 6, strike lines 35 through 37 and substitute "section, a local  
9 government shall establish a process IN ACCORDANCE WITH 34 U.S.C. SEC.  
10 41101, which ~~may~~ MUST be established by ~~resolution or ordinance or~~  
11 ~~otherwise~~ ORDINANCE OR RESOLUTION, IN ACCORDANCE WITH 34 U.S.C.  
12 SEC. 41101; MUST MEET THE CRITERIA ESTABLISHED BY THE FEDERAL".
- 13 Page 6, line 38, strike "41101," and substitute "41101;".
- 14 Page 7, strike lines 12 through 27 and substitute:
- 15 "~~(4) (c.5) (I) An applicant who holds a license or is applying for~~  
16 ~~a license, an owner or prospective owner, or an employee or prospective~~  
17 ~~employee shall submit to a fingerprint-based criminal history record~~  
18 ~~check. The applicant, owner or prospective owner, or employee or~~  
19 ~~prospective employee shall pay the costs associated with the~~  
20 ~~fingerprint-based criminal history record check.~~  
21 ~~(H) A person who is, as of the effective date of this subsection~~  
22 ~~(4)(c.5), an applicant who holds a license, an owner, or an employee shall~~  
23 ~~have the applicant's, owner's, or employee's fingerprints taken by a local~~  
24 ~~law enforcement agency or any third party approved by the Colorado~~  
25 ~~bureau of investigation for the purpose of obtaining a fingerprint-based~~  
26 ~~criminal history record check no later than~~".
- 27 Page 7, strike line 40 and substitute "~~history record check~~".
- 28 Strike "RULE, ORDINANCE, OR REGULATION" and substitute "ORDINANCE  
29 OR RESOLUTION" on: **Page 4**, line 9; and **Page 5**, lines 14 and 19.
