

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

HB25-1220 be amended as follows:

- 1 Amend printed bill, page 8, after line 2 insert:
 - 2 "(14) "NUTRITION DIAGNOSIS" MEANS IDENTIFYING AND LABELING
 - 3 NUTRITION PROBLEMS MANAGED AND TREATED BY A LICENSED DIETITIAN
 - 4 OR A LICENSED NUTRITIONIST BUT DOES NOT INCLUDE A MEDICAL
 - 5 DIAGNOSIS OF THE HEALTH STATUS OF AN INDIVIDUAL."
- 6 Renumber succeeding subsections accordingly.
- 7 Page 15, lines 7 through 10, strike "ON AND AFTER SEPTEMBER 1, 2026,
 - 8 AN INDIVIDUAL WHO PRACTICES AS A DIETITIAN OR WHO HOLDS THEMSELF
 - 9 OUT AS BEING ABLE TO PRACTICE AS A DIETITIAN MUST POSSESS A VALID
 - 10 LICENSE ISSUED PURSUANT TO THIS ARTICLE 223. EACH" and substitute
 - 11 "AN".
- 12 Page 18, lines 22 through 26, strike "ON AND AFTER SEPTEMBER 1, 2026,
 - 13 AN INDIVIDUAL WHO PRACTICES AS A NUTRITIONIST OR WHO HOLDS
 - 14 THEMSELF OUT AS BEING ABLE TO PRACTICE AS A NUTRITIONIST MUST
 - 15 POSSESS A VALID LICENSE ISSUED PURSUANT TO THIS ARTICLE 223. EACH"
 - 16 and substitute "AN".
- 17 Page 27, lines 18 through 20, strike "OR USE OR ASSUME THE TITLE
 - 18 "DIETITIAN", "DIETITIAN NUTRITIONIST", OR "DIETICIAN", OR ANOTHER
 - 19 TITLE INDICATING THAT THE INDIVIDUAL IS A LICENSED DIETITIAN,".
- 20 Page 27, line 21, after "223." insert "AN INDIVIDUAL SHALL NOT USE OR
 - 21 ASSUME THE TITLE "DIETITIAN", "DIETITIAN NUTRITIONIST", OR
 - 22 "DIETICIAN" UNLESS THE INDIVIDUAL HOLDS THE REGISTERED DIETITIAN
 - 23 CREDENTIAL FROM THE COMMISSION ON DIETETIC REGISTRATION OR IS
 - 24 LICENSED AS A DIETITIAN UNDER THIS ARTICLE 223."
- 25 Page 28, lines 11 through 13, strike "OR IDENTIFY THEMSELF USING THE
 - 26 GENERAL TITLES OF "DIETITIAN", "DIETITIAN NUTRITIONIST", OR
 - 27 "NUTRITIONIST"".
- 28 Page 36, lines 8 through 11, strike "AS A DIETITIAN OR A NUTRITIONIST, OR
 - 29 AN INDIVIDUAL WHO PRACTICES OR OFFERS OR ATTEMPTS TO PRACTICE
 - 30 MEDICAL NUTRITION THERAPY, WITHOUT BEING LICENSED PURSUANT TO
 - 31 THIS ARTICLE 223" and substitute "IN VIOLATION OF SECTION 12-223-111".
