

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation, Housing & Local Government.

HB25-1198 be amended as follows:

1 Amend printed bill, page 4, line 22, strike "FIFTEEN" and substitute
2 "TWENTY-ONE".

3 Page 5, after line 2 insert:

4 "(III) ONE MEMBER REPRESENTING THE DEPARTMENT OF
5 AGRICULTURE, APPOINTED BY THE COMMISSIONER OF AGRICULTURE;

6 (IV) ONE MEMBER REPRESENTING COUNTIES AND COMMISSIONERS
7 ACTING TOGETHER, OR ANY SUCCESSOR ORGANIZATION, APPOINTED BY
8 THE EXECUTIVE DIRECTOR OF COUNTIES AND COMMISSIONERS ACTING
9 TOGETHER OR THE EXECUTIVE DIRECTOR'S DESIGNEE;

10 (V) THREE MEMBERS REPRESENTING COMMUNITY PLANNING
11 PROFESSIONALS, APPOINTED BY THE EXECUTIVE DIRECTOR OF THE
12 DEPARTMENT OF LOCAL AFFAIRS;

13 (VI) ONE MEMBER WHO IS A COLORADO RESIDENT REPRESENTING
14 AN INDIGENOUS COMMUNITY, AS DEFINED IN SECTION 24-33.5-2601 (2),
15 AND WHO IS A MEMBER OF A FEDERALLY RECOGNIZED TRIBE WITH
16 HISTORIC TIES TO COLORADO;".

17 Rerumber succeeding subparagraphs accordingly.

18 Page 6, line 14, strike "(3)(a)(IX)" and substitute "(3)(a)(XIII)".

19 Page 6, line 15, strike "(3)(a)(XII)" and substitute "(3)(a)(XVI)".

20 Page 6, line 20, strike "(3)(a)(VI)" and substitute "(3)(a)(X)".

21 Page 6, strike lines 21 through 27.

22 Page 7, strike lines 1 through 13 and substitute "COMMISSION NO LATER
23 THAN DECEMBER 31 OF THE YEAR DURING WHICH THE CONDITION
24 SPECIFIED IN SUBSECTION (11) OF THIS SECTION HAS OCCURRED, DURING
25 WHICH MEETING THE COMMISSION SHALL ELECT A CHAIR FROM AMONG
26 THE COMMISSION'S MEMBERS TO SERVE A TERM NOT TO EXCEED THREE
27 YEARS, AS DETERMINED BY THE COMMISSION, AND SHALL DISCUSS THE
28 COMMISSION'S FUNCTION AND PURPOSE; AND

29 (b) THE COMMISSION SHALL MEET AS NECESSARY WHEN A LOCAL
30 GOVERNMENT REQUESTS ASSISTANCE FROM THE COMMISSION IN
31 ADDRESSING A REGIONAL OPPORTUNITY OR CHALLENGE.".
