- 2 "MODIFICATION THAT".
- 3 Page 4, line 1, strike "SIGNIFICANT THAT IT".
- 4 Page 5, strike lines 4 and 5.
- 5 Rerumber succeeding subsections accordingly.
- 6 Page 6, strike lines 1 through 5 and substitute:
 - 7 (8) "QUALIFIED INDIVIDUAL WITH A DISABILITY" HAS THE SAME
 - 8 MEANING AS SET FORTH IN THE FEDERAL "AMERICANS WITH DISABILITIES
 - 9 ACT OF 1990", 42 U.S.C. SEC. 12101 ET SEQ.
 - 10 (9) "SERIOUS RISK OF INSTITUTIONALIZATION" MEANS WHEN A
 - 11 QUALIFIED INDIVIDUAL WITH A DISABILITY IS LIKELY TO EXPERIENCE A
 - 12 DECLINE IN HEALTH, SAFETY, OR WELFARE THAT WOULD LEAD TO THE
 - 13 PLACEMENT OF THE INDIVIDUAL IN AN INSTITUTION DUE TO AN ACTION OR
 - 14 LACK OF ACTION BY A PUBLIC OR GOVERNMENTAL ENTITY.".
- 15 Page 6, line 12, before "**individuals**" insert "**qualified**".
- 16 Page 6, line 17, strike "TREATMENT OR".
- 17 Page 6, strike lines 21 through 26 and substitute "OTHER QUALIFIED
- 18 INDIVIDUALS WITH DISABILITIES; AND
- 19 (d) THE AFFECTED INDIVIDUAL IS AT SERIOUS RISK OF
- 20 INSTITUTIONALIZATION.".
- 21 Page 8, line 23, strike "AND".
- 22 Page 8, strike line 27 and substitute "DETERMINATIVE; AND
- 23 (V) WHETHER THE PROPOSED MODIFICATION RESULTS IN THE
- 24 REDUCTION OR DELAY OF THE RECEIPT OF COMMUNITY-BASED SERVICES
- 25 FOR OTHER INDIVIDUALS WITH DISABILITIES.".
- 26 Strike "AN" and substitute "A QUALIFIED" on: **Page 5**, line 7; and **Page 6**,
- 27 lines 9 and 13.
- 28 Before "INDIVIDUALS", insert "QUALIFIED" on: **Page 7**, line 6; **Page 8**,
- 29 lines 17, 20, and 25; and **Page 9**, line 2.
