

1 Amend printed bill, page 10, strike line 12 and substitute "portion; and  
2 **add (5)** as follows:".

3 Page 10, strike lines 13 through 27 and substitute:

4 **"25-57-108. Written materials for recipient parents and  
5 gamete donors.** (1) On or before January 1, 2025, the department ~~shall~~  
6 MAY develop written materials for intended recipient parents. The  
7 department ~~shall~~ MAY develop the materials in conjunction with licensed  
8 mental health professionals who have prior documented experience  
9 counseling gamete donors, recipients, and donor-conceived persons, as  
10 well as experience and competency in counseling families with lesbian,  
11 gay, bisexual, and transgender parents and single parents, along with  
12 organizations representing these communities. THE DEPARTMENT SHALL  
13 POST THE WRITTEN MATERIAL ON ITS WEBSITE, WHICH IS DEEMED  
14 SUFFICIENT TO MEET THE REQUIREMENTS IN SUBSECTIONS (3) AND (4) OF  
15 THIS SECTION. GAMETE AGENCIES, GAMETE BANKS, AND FERTILITY CLINICS  
16 ARE NOT REQUIRED TO USE THE WRITTEN MATERIALS DEVELOPED BY THE  
17 DEPARTMENT. The materials must include information on the following  
18 subjects:".

19 Page 11, strike lines 1 through 14 and substitute:

20 **"(2)** On or before January 1, 2025, the department ~~shall~~ MAY  
21 develop written materials for gamete donors. The department shall  
22 develop the materials in conjunction with licensed mental health  
23 professionals who have prior documented experience counseling gamete  
24 donors, recipients, and donor-conceived persons, as well as experience  
25 and competency in counseling families with lesbian, gay, bisexual, and  
26 transgender parents and single parents, along with organizations  
27 representing these communities. THE DEPARTMENT SHALL POST THE  
28 WRITTEN MATERIAL ON ITS WEBSITE, WHICH IS DEEMED SUFFICIENT TO  
29 MEET THE REQUIREMENTS IN SUBSECTIONS (3) AND (4) OF THIS SECTION.  
30 GAMETE AGENCIES, GAMETE BANKS, AND FERTILITY CLINICS ARE NOT  
31 REQUIRED TO USE THE WRITTEN MATERIALS DEVELOPED BY THE  
32 DEPARTMENT. The materials must include information on the following  
33 subjects:".

34 Page 11, after line 18 insert:

35 **"(5)** A GAMETE AGENCY, GAMETE BANK, OR FERTILITY CLINIC  
36 SHALL DEVELOP WRITTEN MATERIALS TO BE SHARED WITH INTENDED  
37 RECIPIENT PARENTS AND GAMETE DONORS BASED ON GUIDELINES FOR  
38 PSYCHOEDUCATIONAL COUNSELING PUBLISHED BY THE AMERICAN  
39 SOCIETY OF REPRODUCTIVE MEDICINE."
