HB25-1162 be amended as follows:

1 Amend proposed committee amendment (HB 1162_L.001), page 1 of the
2 amendment, strike line 2 and substitute:

3 "Page 3, strike lines 1 through 4 and substitute:

4 **SECTION 1.** In Colorado Revised Statutes, 25.5-4-205, **add**
5 (3)(b)(I.5)(H) as follows:

6 **25.5-4-205. Application - verification of eligibility -**
7 **demonstration project - rules.** (3) (b) (I.5) (H) ON OR BEFORE JULY 1,
8 2028, THE STATE DEPARTMENT SHALL SEEK ANY NECESSARY FEDERAL
9 AUTHORIZATION TO ALLOW THE STATE DEPARTMENT TO DETERMINE A
10 MEMBER'S ELIGIBILITY FOR REENROLLMENT WITHOUT CHECKING
11 FEDERALLY APPROVED ELECTRONIC DATA SOURCES OR REQUESTING
12 ADDITIONAL VERIFICATION, IF THE MEMBER'S INCOME CONSISTS SOLELY OF
13 SOCIAL SECURITY INCOME OR OTHER SOURCE OF STABLE INCOME OR
14 ASSETS. THE DEPARTMENT, IN CONSULTATION WITH MEDICAID MEMBERS
15 AND ADVOCACY GROUPS, SHALL MAKE A REASONABLE DETERMINATION OF
16 WHAT TYPES OF INCOME AND ASSETS ARE CONSIDERED STABLE OR
17 EXPECTED TO DECREASE IN VALUE AND ASSUME NO CHANGE IN THOSE
18 INCOME SOURCES OR ASSETS WITHOUT CHECKING FEDERALLY APPROVED
19 ELECTRONIC DATA SOURCES OR REQUESTING ADDITIONAL VERIFICATION.
20 ON OR BEFORE JULY 1, 2028, THE STATE DEPARTMENT SHALL SEEK ANY
21 NECESSARY FEDERAL AUTHORIZATION TO ALLOW THE STATE DEPARTMENT
22 TO DETERMINE A MEMBER'S ELIGIBILITY FOR REENROLLMENT WITHOUT
23 REQUIRING ADDITIONAL VERIFICATION OF THE MEMBER'S INCOME OR
24 ASSETS, IF THE MEMBER'S INCOME OR ASSETS HAS NOT CHANGED SINCE
25 THE INITIAL VERIFICATION THAT TOOK PLACE DURING THE APPLICATION
26 PROCESS OR AS SPECIFIED THROUGH FEDERAL AUTHORIZATION."

27 Page 1 of the amendment, strike line 18 and substitute "Page 3, strike
28 lines 22 through 27."

29 Page 1 of the amendment, strike lines 19 through 30.

30 Page 2 of the amendment, strike lines 1 through 11.
