

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

SB25-299 be amended as follows:

1 Amend reengrossed bill, page 8, line 12, strike "ON OR".

2 Page 9, strike line 5 and substitute "**required - certification required.**

3 (1) ON AND AFTER JANUARY 1, 2026, A PERSON SHALL NOT SELL OR
4 LEASE, OFFER FOR SALE OR LEASE, ADVERTISE, OR PROVIDE A RESIDENTIAL
5 SOLAR ELECTRIC SYSTEM OR RESIDENTIAL BATTERY ENERGY STORAGE
6 SYSTEM TO A CONSUMER IN THE STATE UNLESS THE PERSON HAS OBTAINED
7 A CERTIFICATION FROM THE COMMISSION PURSUANT TO SECTION 40-2-311.

8 (2) (a) BEFORE ENTERING INTO AN AGREEMENT WITH A".

9 Renumber succeeding subsections accordingly.

10 Page 12, line 12, strike "(1)(a)" and substitute "(2)(a)".

11 Page 25, line 18, strike "**incentives.**" and substitute "**incentives -**
12 **commission to establish certification process.**".

13 Page 26, after line 5 insert:

14 "(2) THE COMMISSION SHALL CAUSE TO BE PROVIDED TO ALL
15 SOLAR SALES COMPANIES AND SALESPERSONS IN THE STATE AN
16 EXPLANATION OF THE REQUIREMENTS OF THIS PART 3. THE EXPLANATION
17 SHALL BE PROVIDED:

18 (a) BY CERTIFIED MAIL, RETURN RECEIPT REQUESTED, AT THE
19 LAST-KNOWN BUSINESS ADDRESS OF EACH SOLAR SALES COMPANY AND
20 SALESPERSON; OR

21 (b) THROUGH ELECTRONIC MEANS, WHICH REQUIRES THE SOLAR
22 SALES COMPANY OR SALESPERSON TO ACKNOWLEDGE RECEIPT OF THE
23 EXPLANATION.

24 (3) (a) THE COMMISSION SHALL ESTABLISH REQUIREMENTS FOR
25 THE CERTIFICATION OF A SOLAR SALES COMPANY AND OF A SALESPERSON.
26 THE COMMISSION SHALL NOT ESTABLISH ANY REQUIREMENTS FOR
27 CERTIFICATION THAT ARE MORE STRINGENT THAN THE REQUIREMENTS OF
28 ANY APPLICABLE FEDERAL LAW; EXCEPT THAT ALL APPLICANTS SHALL
29 COMPLETE THE EDUCATIONAL COURSE DESCRIBED IN SUBSECTION (3)(b)
30 OF THIS SECTION.

31 (b) THE REQUIREMENTS ESTABLISHED BY THE COMMISSION
32 PURSUANT TO THIS SUBSECTION (3) MUST INCLUDE A REQUIREMENT THAT
33 A SOLAR SALES COMPANY OR SALESPERSON COMPLETE AN EDUCATIONAL
34 COURSE THAT PROVIDES INFORMATION ABOUT THE DISCLOSURE AND
35 AGREEMENT REQUIREMENTS SET FORTH IN THIS PART 3."

36 Strike "(1)" and substitute "(2)" on: **Page 12**, line 16; **Page 13**, line 9; and
37 **Page 14**, line 8.
