

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB25-1195 be amended as follows:

- 1 Amend printed bill, page 2, strike lines 2 through 5.
- 2 Page 3, strike lines 1 through 12.
- 3 Renumber succeeding sections accordingly.
- 4 Page 4, strike lines 2 and 3 and substitute:
  - 5 "(VI) THE SPOUSE OR CIVIL UNION PARTNER OF AN INDIVIDUAL
  - 6 SPECIFIED IN".
- 7 Page 4, strike lines 11 through 27.
- 8 Page 5, strike lines 1 through 4 and substitute:
  - 9 "(c) A FIRST RESPONDER MAY MAKE THE REQUEST FOR
  - 10 CONFIDENTIALITY ALLOWED BY SUBSECTION (3.7)(b) OF THIS SECTION TO
  - 11 THE COUNTY CLERK AND RECORDER WHERE THE INDIVIDUAL MAKING THE
  - 12 REQUEST RESIDES, ON AN APPLICATION FORM APPROVED BY THE
  - 13 SECRETARY OF STATE. THE APPLICATION FORM SHALL PROVIDE SPACE
  - 14 FOR".
- 15 Page 5, line 12, after "SPOUSE" insert "OR CIVIL UNION PARTNER".
- 16 Page 5, strike lines 19 through 27 and substitute "BUT IS NOT A FIRST
- 17 RESPONDER.
  - 18 (d) EACH COUNTY CLERK AND RECORDER SHALL:
    - 19 (I) MAKE THE CONFIDENTIALITY REQUEST APPLICATION FORMS
    - 20 AVAILABLE IN THEIR OFFICES;
    - 21 (II) PROVIDE THE CONFIDENTIALITY REQUEST APPLICATION FORMS
    - 22 TO INTERESTED PERSONS BY UNITED STATES MAIL, EMAIL DELIVERY, OR
    - 23 FACSIMILE TRANSMISSION, IF REQUESTED;
    - 24 (III) PERMIT FIRST RESPONDERS TO SUBMIT COMPLETED AND
    - 25 SIGNED CONFIDENTIALITY REQUEST APPLICATION FORMS BY UNITED
    - 26 STATES MAIL, PERSONAL DELIVERY, EMAIL DELIVERY, OR FACSIMILE
    - 27 TRANSMISSION; AND
    - 28 (IV) NOT CHARGE A PROCESSING OR ANY OTHER FEE IN
    - 29 CONNECTION WITH A FIRST RESPONDER'S".
- 30 Reletter succeeding paragraphs accordingly.
